1 2 3 4 5	publicly denounce the crimes against humanity occurring in Iraq and to take every step possible PRUDENT ACTION to < protect Iraqi Christians and other religious minorities from persecution from the Islamic State of Iraq and the Levant.
6	WHEREAS, Iraq is currently embroiled in a surge of violence
7	arising from an Islamic State in Iraq and the Levant (ISIL)-led
8	offensive that began in the Anbar province, has spread to key
9	locations such as Mosul, Tikrit and Samarra and continues to
_0	engulf the region in violence and instability; and
1	WHEREAS, On June 29, 2014, ISIL leader Abu Bakr al-Baghdadi
_2	renamed the group the Islamic State and pronounced himself
13	caliph of a new Islamic Caliphate encompassing the areas under
4	his control; and
. 5	WHEREAS, Mr. al-Baghdadi has a stated mission of spreading
- 6	the Islamic State and caliphate across the region through
_7	violence against Shiites, non-Muslims and unsupportive Sunnis;

- 2 WHEREAS, Upon taking control over northwestern Iraq and
- 3 Syria, ISIL issued a warning to Christians living under its
- 4 jurisdiction to convert to Islam, to pay a burdensome religious
- 5 tax or to be executed; and
- 6 WHEREAS, Over 1,000,000 people have been displaced by
- 7 violence in Iraq and reports have surfaced of targeted
- 8 harassment, persecution and killings of Iraqi religious
- 9 minorities by the Islamic State with little to no protection
- 10 from the Government of Iraq and other security forces; and
- 11 WHEREAS, Reports indicate that Islamic State militants have
- 12 been marking homes of Christians with the Arabic letter "N," for
- 13 "Nazara" (Christian), beheading children and crucifying
- 14 captives. ISIL's actions are a crime against humanity and
- 15 nothing more than genocide or ethnic cleansing against religious
- 16 minority groups; and
- 17 WHEREAS, The Iraqi constitution provides for religious
- 18 freedom by stating:
- 19 (1) "no law may be enacted that contradicts the
- 20 principles of democracy";
- 21 (2) "no law may be enacted that contradicts the rights
- and basic freedoms stipulated in this Constitution"; and
- 23 (3) "[This Constitution] guarantees the full religious
- 24 rights to freedom of religious belief and practice of all
- individuals such as Christians, Yazidis, and Mandean
- 26 Sabeans";
- 27 and
- 28 WHEREAS, President Barack Obama recently declared on
- 29 Religious Freedom Day, "Foremost among the rights Americans hold
- 30 sacred is the freedom to worship as we choose ... [W]e also

- 1 remember that religious liberty is not just an American right;
- 2 it is a universal human right to be protected here at home and
- 3 across the globe. This freedom is an essential part of human
- 4 dignity, and without it our world cannot know lasting peace";
- 5 and
- 6 WHEREAS, The atrocities being committed against Christians
- 7 and other ethnic and religious minority communities in Iraq are
- 8 unconscionable and represent a crime against humanity; therefore
- 9 be it
- 10 RESOLVED, That the Senate of the Commonwealth of Pennsylvania
- 11 urge the President and the Congress of the United States to
- 12 publicly denounce the crimes against humanity occurring in Iraq
- 13 and to take every step possible PRUDENT ACTION to protect Iraqi <--
- 14 Christians and other religious minorities from persecution from
- 15 the Islamic State of Iraq and the Levant; and
- 16 RESOLVED, That the President and Congress urge the Government
- 17 of Iraq to take immediate steps to protect the safety and
- 18 constitutional rights of all Iraqi citizens; and
- 19 RESOLVED, That the President and Congress work with the
- 20 Government of Iraq to bring Islamic State militants to justice
- 21 before an international forum for war crimes and crimes against
- 22 humanity; be it further
- 23 RESOLVED, That copies of this resolution be transmitted to
- 24 the President of the United States, to the presiding officers of
- 25 each house of Congress and to each member of Congress from
- 26 Pennsylvania.
