(c) The report shall also show the number of offenders in such cases punished by

- 1 <u>sentence or imprisonment, or by the payment of a fine, or by both fine and imprisonment, or by</u>
- 2 suspended or deferred sentence or probation, with the sentences and fines specified in each
- 3 <u>instance.</u>
- 4 (d) The report shall be subdivided to show the sex of the offenders and the age of the
- 5 offenders, arranged by decades. The report shall be compiled using statistics provided by the
- 6 Rhode Island statewide judicial information system.
- 7 SECTION 2. This act shall take effect upon passage.
