## SENATE BILL NO. 87

Introduced by: The Committee on Appropriations at the request of the Office of the  
Governor

1 FOR AN ACT ENTITLED, An Act to make appropriations from the water and environment  
2 fund, the water pollution control revolving fund subfund, and the drinking water revolving  
3 fund subfund for various water and environmental purposes, and to declare an emergency.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

5 Section 1. There is hereby appropriated from the South Dakota water and environment fund  
6 established pursuant to § 46A-1-60, the sum of one million dollars (\$1,000,000), or so much  
7 thereof as may be necessary, to provide funds to the South Dakota Board of Water and Natural  
8 Resources for the purpose of providing a five hundred thousand dollar grant and a five hundred  
9 thousand dollar loan to the project sponsors for the engineering design, preconstruction  
10 activities, and construction of the facilities included in the Belle Fourche irrigation upgrade  
11 project as authorized in § 46A-1-13.12. Funds shall be provided according to terms and  
12 conditions established by the Board of Water and Natural Resources.

13 Section 2. There is hereby appropriated from the South Dakota water and environment fund  
14 established pursuant to § 46A-1-60, the sum of twelve million dollars (\$12,000,000), or so much  
15 thereof as may be necessary, to the South Dakota Board of Water and Natural Resources for the



1 purpose of providing grants and loans to project sponsors under the consolidated water facilities  
2 construction program established pursuant to § 46A-1-63.1. Funds shall be provided according  
3 to terms and conditions established by the Board of Water and Natural Resources.

4 Section 3. There is hereby appropriated from the South Dakota water and environment fund  
5 established pursuant to § 46A-1-60, the sum of two million six hundred fifty thousand dollars  
6 (\$2,650,000), or so much thereof that may be necessary, to the South Dakota Board of Water  
7 and Natural Resources for the purpose of providing grants and loans to project sponsors under  
8 the solid waste management program established pursuant to § 46A-1-83. Funds shall be  
9 provided according to the terms and conditions established by the Board of Water and Natural  
10 Resources. The board may use up to ten thousand dollars of the funds appropriated by this  
11 section to contract for services to process and review loan applications as authorized under  
12 chapter 46A-1. Notwithstanding § 46A-1-67, the term of years for loans under this section may  
13 be extended to the useful life of the facilities being financed.

14 Section 4. There is hereby appropriated from administrative expense surcharge fees  
15 deposited in the South Dakota state water pollution control revolving fund program subfund  
16 established pursuant to § 46A-1-60.1, the sum of eight hundred thousand dollars (\$800,000),  
17 or so much thereof as may be necessary, to the South Dakota Board of Water and Natural  
18 Resources for the purpose of providing water quality grants under the state water pollution  
19 control revolving fund program established pursuant to § 46A-1-60.1. Funds shall be provided  
20 according to terms and conditions established by the Board of Water and Natural Resources.

21 Section 5. There is hereby appropriated from administrative expense surcharge fees  
22 deposited in the South Dakota state water pollution control revolving fund program subfund  
23 established pursuant to § 46A-1-60.1, the sum of one hundred thousand dollars (\$100,000), or  
24 so much thereof as may be necessary, to the South Dakota Board of Water and Natural

1 Resources for the purpose of contracting for the preparation of applications and administration  
2 of clean water state revolving fund loans under the state water pollution control revolving fund  
3 program established pursuant to § 46A-1-60.1. Funds shall be provided according to terms and  
4 conditions established by the Board of Water and Natural Resources.

5 Section 6. There is hereby appropriated from administrative expense surcharge fees  
6 deposited in the South Dakota state drinking water revolving fund program subfund established  
7 pursuant to § 46A-1-60.1, the sum of one hundred thousand dollars (\$100,000), or so much  
8 thereof as may be necessary, to the South Dakota Board of Water and Natural Resources for the  
9 purpose of contracting for the preparation of applications and administration of drinking water  
10 state revolving fund loans under the state drinking water revolving fund program established  
11 pursuant to § 46A-1-60.1. Funds shall be provided according to terms and conditions established  
12 by the Board of Water and Natural Resources.

13 Section 7. There is hereby appropriated from federal funds deposited in the South Dakota  
14 state drinking water revolving fund program subfund established pursuant to § 46A-1-60.1, the  
15 sum of two hundred thousand dollars (\$200,000), or so much thereof as may be necessary, to  
16 the South Dakota Board of Water and Natural Resources for the purpose of providing small  
17 system technical assistance set-aside grants to project sponsors under the state drinking water  
18 revolving fund program established pursuant to § 46A-1-60.1. Funds shall be provided  
19 according to terms and conditions established by the Board of Water and Natural Resources.

20 Section 8. Any amounts appropriated in this Act not lawfully expended or obligated shall  
21 revert in accordance with the procedures prescribed in chapter 4-8.

22 Section 9. Whereas, this Act is necessary for the support of the state government and its  
23 existing public institutions, an emergency is hereby declared to exist, and this Act shall be in  
24 full force and effect from and after its passage and approval.
