7	Section 203 of the Investment Advisers Act of 1940
8	(15 U.S.C. 80b-3) is amended by adding at the end the
9	following:
10	"(o) Exemption of and Reporting Require-
11	MENTS BY PRIVATE EQUITY FUNDS ADVISORS.—
12	"(1) In general.—Except as provided in this
13	subsection, no investment adviser shall be subject to
14	the registration or reporting requirements of this
15	title with respect to the provision of investment ad-
16	vice relating to a private equity fund or funds, pro-
17	vided that each such fund has not borrowed and
18	does not have outstanding a principal amount in ex-
19	cess of twice its invested capital commitments.
20	"(2) Maintenance of records and access
21	BY COMMISSION.—Not later than 6 months after the
22	date of enactment of this subsection, the Commis-
23	sion shall issue final rules—
24	"(A) to require investment advisers de-
25	scribed in paragraph (1) to maintain such
26	records and provide to the Commission such an-

1	nual or other reports as the Commission taking
2	into account fund size, governance, investment
3	strategy, risk, and other factors, as the Com-
4	mission determines necessary and appropriate
5	in the public interest and for the protection of
6	investors; and
7	"(B) to define the term 'private equity
8	fund' for purposes of this subsection.".
