#### 1 SECTION 1. GETTYSBURG NATIONAL MILITARY PARK.

2	(a) Boundary Revision.—Section 1 of the Act ti-
3	tled "An Act to revise the boundary of Gettysburg Na-
4	tional Military Park in the Commonwealth of Pennsyl-
5	vania, and for other purposes", approved August 17, 1990
6	(16 U.S.C. 430g-4), is amended by adding at the end the
7	following new subsection:
8	"(d) Additional Land.—
9	"(1) COVERED LAND; CONDITION.—In addition
10	to the land identified in subsections (a) and (b), the
11	park shall include the following, as depicted on the
12	maps titled 'Gettysburg National Military Park Pro-
13	posed Boundary Addition', numbered 305/80,045,
14	and dated January 2010, if the owner of the prop-
15	erty has provided written consent to inclusion:
16	"(A) The land and interests in land com-
17	monly known as the 'Gettysburg Train Station'
18	and its immediate surroundings in the Borough
19	of Gettysburg.
20	"(B) The land and interests in land lo-
21	cated along Plum Run in Cumberland Town-
22	ship.
23	"(2) Rule of Construction.—Nothing in
24	paragraph (1), the acquisition of property within the
25	area described in such paragraph, or the manage-
26	ment plan for such acquired property shall be con-

- 1 strued to create buffer zones outside of such prop-
- 2 erty. That an activity or use can be seen or heard
- 3 from within such acquired property shall not pre-
- 4 clude the conduct of that activity or use outside such
- 5 property.".
- 6 (b) Limited Acquisition Authority.—Section
- 7 2(a) of that Act (16 U.S.C. 430g-5(a)) is amended in the
- 8 first sentence by inserting before the period the following:
- 9 ", except that the Secretary is authorized to acquire prop-
- 10 erty within the area described in section 1(d) by donation
- 11 only".
