A BILL

To amend the Help America Vote Act of 2002 to require States which require individuals to present a photo identification as a condition of voting in elections for Federal office to accept a photo identification presented by a student which is issued by the school the student attends.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Equal Access to Sup-
5 port Youth Voting Act” or the “EASY Voting Act”.

1 **SEC. 2. REQUIRING STATES TO ACCEPT STUDENT IDENTI-**
2 **FICATIONS FOR PURPOSES OF MEETING**
3 **VOTER IDENTIFICATION REQUIREMENTS.**

4 (a) ACCEPTANCE OF STUDENT IDENTIFICATIONS.—
5 Title III of the Help America Vote Act of 2002 (42 U.S.C.
6 15481 et seq.) is amended by inserting after section 303
7 the following new section:

8 **“SEC. 303A. REQUIRING ACCEPTANCE OF STUDENT PHOTO**
9 **IDENTIFICATION AS CURRENT AND VALID**
10 **PHOTO IDENTIFICATION.**

11 “(a) ACCEPTANCE OF STUDENT IDENTIFICATIONS.—
12 A State or local election official shall accept a current and
13 valid student photo identification issued by an institution
14 of higher education to a student attending such institution
15 of higher education as a current and valid photo identifica-
16 tion for purposes of section 303(b)(2) or of any State or
17 local law which requires an individual to produce a current
18 and valid photo identification to obtain a ballot or vote
19 in an election for Federal office.

20 “(b) DEFINITION.—In this section, the term ‘institu-
21 tion of higher education’ has the meaning given such term
22 in section 101 of the Higher Education Act of 1965 (20
23 U.S.C. 1001), except that such term includes a propri-
24 etary institution of higher education described in section
25 102(b) of such Act (20 U.S.C. 1002(b)).”

1 (b) ENFORCEMENT.—Section 401 of such Act (42
2 U.S.C. 15511) is amended by striking “and 303” and in-
3 serting “303, and 303A”.

4 (c) CLERICAL AMENDMENT.—The table of contents
5 of such Act is amended by inserting after the item relating
6 to section 303 the following new item:

“Sec. 303A. Requiring acceptance of student photo identification as current
and valid photo identification.”.

7 (d) EFFECTIVE DATE.—The amendments made by
8 this section shall apply with respect to elections occurring
9 on or after the date of the enactment of this Act.
