A BILL

To enhance the operation of the Dwight D. Eisenhower
Memorial Commission.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Dwight D. Eisenhower*
5 *Memorial Commission Reform Act”.*

6 **SEC. 2. DWIGHT D. EISENHOWER MEMORIAL.**

7 *(a) AMENDMENTS.—Section 8162 of Public Law 106–*
8 *79 (40 U.S.C. 8903 note) is amended as follows:*

9 *(1) In subsection (c)—*

10 *(A) in paragraph (2) by striking “Members*
11 *of the Senate” and inserting “persons”; and*

12 *(B) in paragraph (3), by striking “Members*
13 *of the House of Representatives” and inserting*
14 *“persons”.*

15 *(2) By redesignating subsections (f), (g), (h), (i),*
16 *(j), (k), (l), (m), (n), (o), (p), and (q) as subsections*
17 *(g), (h), (i), (j), (k), (l), (m), (n), (o), (p), (q), and*
18 *(r), respectively.*

19 *(3) By inserting after subsection (e) the fol-*
20 *lowing:*

21 *“(f) APPOINTMENTS.—Each appointment of a Com-*
22 *mission member shall be made in consultation with the Ei-*
23 *senhower Foundation, a section 501(c)(3) public foundation*
24 *located in Abilene, Kansas.”.*

1 (b) *TERMINATION OF COMMISSION MEMBERSHIP AND*
2 *STAFF; RECORDS.—*

3 (1) *TERMINATION OF MEMBERSHIP.—The term*
4 *as a member of the Dwight D. Eisenhower Memorial*
5 *Commission of each individual serving as such a*
6 *member on the date of the enactment of this Act is*
7 *hereby terminated.*

8 (2) *STAFF.—The employment as Executive Di-*
9 *rector and other staff of the Commission of each indi-*
10 *vidual so employed on the date of the enactment of*
11 *this Act is hereby terminated effective on the date that*
12 *is 30 days after the date of enactment of this Act.*

13 (3) *RECORDS.—Any records of the Commission*
14 *in existence on the date that the staff is no longer em-*
15 *ployed by the Commission under paragraph (2) shall*
16 *be retained by the General Services Administration or*
17 *the Secretary of the Interior until such time as a new*
18 *Dwight D. Eisenhower Memorial Commission is ap-*
19 *pointed and staffed. The records of the former Com-*
20 *mission shall be transferred to the newly appointed*
21 *Commission as soon as possible.*
