A BILL

To include community partners and intermediaries in the planning and delivery of education and related programs, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE; TABLE OF CONTENTS.**

5 Section 1111 of the Elementary and Secondary Edu-
6 cation Act of 1965 (20 U.S.C. 6311) is amended—

7 (1) in subsection (b)(2)(C)(vii)—

8 (A) by striking “and changes in” and in-
9 serting “changes in”; and

1 (B) by inserting before the period at the
2 end the following: “, and measures of the at-
3 tainment of 21st Century skills (such as critical
4 thinking, problem-solving, communication, and
5 collaboration)”;

6 (2) in subsection (b)(2)(D)(i), by inserting “,
7 and aligned with the program the State will carry
8 out with funds received under this part” after “if
9 any”; and

10 (3) in subsection (h)(1)(C)—

11 (A) by striking “and” at the end of clause

20 received under this part and activities in re-
21 sponse to changes in student needs or to new

23 “(S) a description of how the local edu-
24 cational agency will carry out programs with
25 funds received under this part in partnership

1 with one or more community partners, includ-
2 ing through joint planning and implementation,
3 shared professional development designed to im-
4 prove the effectiveness of school and community
5 partner staff, development and implementation
6 of shared data systems that support the im-
7 provement of such programs and the improve-
8 ment of the outcomes of such programs, and
9 the alignment and coordination of local edu-
10 cational agency, school, and community partner
11 goals, activities, and training; and

12 “(T) a description of how the local edu-
13 cational will carry out programs with funds re-
14 ceived under this part with the involvement of
15 one or more intermediary organizations that
16 will assist the agency and its schools by train-
17 ing staff, providing technical assistance that is
18 designed to ensure continuous improvement,
19 helping to ensure accountability for results, and
20 helping to ensure that such funds flow quickly
21 and effectively to effective service providers and
22 activities.”.

23 **SEC. 103. SCHOOLWIDE PROGRAMS.**

24 Section 1114(b)(1)(J) of the Elementary and Sec-
25 ondary Education Act of 1965 (20 U.S.C. 6314(b)(1)(J))

1 is amended by inserting “, with the assistance of one or
 2 more intermediary organizations described in section
 3 1112(b)(1)(T),” after “Coordination and integration”.

4 **SEC. 104. TARGETED ASSISTANCE SCHOOLS.**

5 Section 1115(c)(1)(H) of the Elementary and Sec-
 6 ondary Education Act of 1965 (20 U.S.C. 6315(c)(1)(H))
 7 is amended by inserting “, with the assistance of one or
 8 more intermediary organizations described in section
 9 1112(b)(1)(T),” after “coordinate and integrate”.

10 **SEC. 105. ACADEMIC ASSESSMENT AND LOCAL EDU-**
 11 **CATIONAL AGENCY AND SCHOOL IMPROVE-**
 12 **MENT.**

12 plementation of shared data systems that
13 support program improvement and the im-
14 provement of program outcomes, and the
15 alignment and coordination of local edu-
16 cational agency, school, and community
17 partner goals, activities, and training; and

18 “(ii) with the involvement of one or
19 more intermediary organizations that will
20 assist the agency and its schools by train-
21 ing staff, providing technical assistance
22 that is designed to ensure continuous im-
23 provement, helping to ensure accountability
24 for results, and helping to ensure that pro-

1 gram funds flow quickly and effectively to
2 effective service providers and activities.”.

3 **SEC. 107. EVALUATIONS.**

4 Section 1501(a)(2) of the Elementary and Secondary
5 Education Act of 1965 (20 U.S.C. 6491(a)(2)) is amend-
6 ed—

7 (1) by redesignating subparagraph (O) as sub-

9 (2) by inserting after subparagraph (N) the fol-

12 agencies are involving community partners and
13 intermediary organizations in their activities
14 carried out under section 1003(g) and part A,
15 and the impact of that involvement.

16 “(P) The implementation of the data-shar-
17 ing agreements entered into under section
18 1112(b)(1)(E), and the impact of that imple-
19 mentation.”.

20 **SEC. 108. DEFINITIONS.**

21 Section 9101 of the Elementary and Secondary Edu-

24 “(44) COMMUNITY PARTNER.—The term ‘com-
25 munity partner’ means a nonprofit or public organi-

1 zation that has expertise in the planning and deliv-
2 ery of education and related programs, in forging co-
3 ordination and cooperation between educators and
4 other members of the community, or in training edu-
5 cators and other deliverers of educational services.

6 “(45) INTERMEDIARY ORGANIZATION.—The
7 term ‘intermediary organization’ means a nonprofit
8 organization that has expertise in training, forging
9 public-private partnerships, systems development,
10 capacity-building, improving scalability, evaluation,
11 and the effective use of data to improve the progress
12 of students, schools and other educational institu-
13 tions, and education programs.”.

12 tutions of higher education, and programs.”; and

14 designated) the following new paragraph:

15 “(20) INTERMEDIARY ORGANIZATION.—The
16 term ‘intermediary organization’ means a nonprofit
17 organization that has expertise in training, forging
18 public-private partnerships, systems development,
19 capacity-building, improving scalability, and evalua-
20 tion.”.

21 **SEC. 202. ATTAINMENT OF 21ST CENTURY SKILLS.**

22 (a) ACCOUNTABILITY.—Section 113(b)(2)(C) of the

25 by inserting “attainment of 21st century skills (such as

1 critical thinking, problem-solving, communication, and col-
2 laboration) and” after “such as”.

3 (b) LOCAL AND STATE REPORTS.—Section 113 of
4 such Act is further amended—

5 (1) in subsection (b)(4)(C)(ii)—

6 (A) in subclause (I), by striking “; and”
7 and inserting a semicolon;

8 (B) in subclause (II), by striking the pe-
9 riod and inserting “; and”; and

10 (C) by inserting after subclause (II) the
11 following new subclause:

12 “(III) describe the progress of
13 career and technical education stu-
14 dents served by the eligible recipient
15 in attaining 21st century skills (such

15 zations and community partners”;

18 inserting a semicolon;

19 (B) in clause (iv), by striking the period
20 and inserting a semicolon; and

21 (C) by inserting after clause (iv) the fol-
22 lowing new clauses:

24 with one or more community partners, in-
25 cluding through joint planning and imple-

1 mentation, shared professional develop-
2 ment designed to improve the effectiveness

17 countability for results, and helping to en-
18 sure that program funds flow quickly and
19 effectively to effective service providers and
20 activities.”; and

16 lowing new paragraphs:

18 agreements that the eligible recipient agency has en-
19 tered into with other agencies and organizations so
20 as to provide for shared access to information on
21 student progress and success (consistent with the re-

16 and other agencies and organizations that provide

13 force development service providers and other mem-
14 bers of the community, or in training service pro-
15 viders.”; and

16 (3) by inserting after paragraph (30) (as so re-
17 designated) the following new paragraph:

18 “(31) INTERMEDIARY ORGANIZATION.—Except
19 as otherwise specified in section 203, the term
20 ‘intermediary organization’ means a nonprofit orga-

13 at the end; and

14 (3) by inserting after subparagraph (D), the
15 following new subparagraph:

16 “(E) each local board shall include rep-
17 resentatives of community partners and inter-
18 mediary organizations; and”.

19 (b) LOCAL PLANS.—Section 108(b) of such Act (29
20 U.S.C. 3123(b)) is amended—

21 (1) by redesignating paragraph (22) as para-
22 graph (23);

23 (2) in paragraph (21), by striking “and” at the
24 end; and

1 (3) by inserting after paragraph (21), the fol-
2 lowing new paragraph:

3 “(22) a description of the data-sharing agree-
4 ment or agreements that the local board has entered
5 into with other agencies and organizations so as to

24 ordination and cooperation between educators and
25 other members of the community, or in training edu-

1 cators and other deliverers of educational services.”;
2 and

3 (3) by inserting after paragraph (13) (as so re-
4 designated) the following new paragraph:

5 “(14) INTERMEDIARY ORGANIZATION.—The
6 term ‘intermediary organization’ means a nonprofit
7 organization that has expertise in training, forging
8 public-private partnerships, systems development,
9 capacity-building, improving scalability, evaluation,
10 and development and implementation of data sys-
11 tems that measure the progress of students, schools,
12 and other educational institutions and programs.”.

13 (b) GRANTS AND CONTRACTS FOR ELIGIBLE PRO-
14 VIDERS.—Section 231(e)(10) of such Act (29 U.S.C.
15 3321(e)(10)) is amended—

16 (1) by inserting “and data-sharing arrange-
17 ments (designed to provide for shared access to in-
18 formation on student progress (consistent with the
19 requirements of subpart 4 of part C of the General
20 Education Provisions Act), integrated planning, and
21 coordinated adjustments in program strategies and
22 activities in response to changes in student needs or
23 to new challenges))” after “strong links”;

1 (2) by inserting “community partners, inter-
2 mediary organizations,” after “postsecondary edu-
3 cational institutions,”; and

4 (3) by striking “nonprofit organizations, and
5 intermediaries” and inserting “and nonprofit organi-
6 zations”.

7 (c) LOCAL PLAN.—Section 232(2) of such Act is
8 amended by inserting “and data-sharing agreements”
9 after “cooperative agreements”.

 6 partnerships, systems development, capacity-building, im-
 7 proving scalability, evaluation, and development and im-
 8 plementation of data systems that measure the progress
 9 of students, schools and other educational institutions,
 10 and programs.”.

11 **SEC. 402. TRIO PROGRAMS.**

12 Section 402A of the Higher Education Act of 1965
 13 (20 U.S.C. 1070a–11) is amended—

14 (1) in subsection (b)(1)—

15 (A) by striking “For the purposes de-
 16 scribed” and inserting the following:

17 “(A) IN GENERAL.—For the purposes de-
 18 scribed”; and

19 (B) by adding at the end the following:

20 “(B) COMMUNITY PARTNERS AND INTER-
 21 MEDIARY ORGANIZATIONS.—An eligible entity de-
 22 scribed in subparagraph (A) of a grant or contract
 23 under this chapter shall, to the extent feasible, carry
 24 out the grant or contract—

1 “(i) with one or more community partners,
2 including through joint planning and implemen-
3 tation, shared professional development de-
4 signed to improve the effectiveness of such eligi-
5 ble entity and community partner staff, devel-
6 opment and implementation of shared data sys-
7 tems that support the improvement of the oper-
8 ations and outcomes of the program carried out
9 with such grant or contract, and the alignment
10 and coordination of such eligible entity and
11 community partner goals, activities, and train-
12 ing; and

13 “(ii) with the involvement of one or more
14 intermediary organizations that will assist such
15 eligible entity by training staff, providing tech-
16 nical assistance that is designed to ensure con-
17 tinuous improvement, helping to ensure ac-
18 countability for results, and helping to ensure
19 that the grant or contract funds flow quickly
20 and effectively to effective service providers and
21 activities.”;

22 (2) in subsection (c)(6), by adding at the end
23 the following: “The Secretary shall also encourage
24 recipients of grants and contracts under this chapter
25 to enter into data-sharing agreements with other

1 agencies and organizations so as to provide for
2 shared access to information on student progress
3 and success (consistent with the requirements of
4 subpart 4 of part C of the General Education Provi-
5 sions Act (20 U.S.C. 1232f et seq.)), integrated
6 planning and review of the data, and coordinated ad-
7 justments in program strategies and activities in re-
8 sponse to changes in student needs or to new chal-
9 lenges.”; and

10 (3) in subsection (f)(3)—

11 (A) in subparagraph (A)—

12 (i) by redesignating clauses (v) and
13 (vi), as clauses (vi) and (vii), respectively;
14 and

15 (ii) by inserting after clause (iv) the
16 following new clause:

17 “(v) student acquisition of 21st Cen-
18 tury skills (such as critical thinking, prob-
19 lem-solving, communication and collabora-
20 tion);”; and

21 (B) in subparagraph (B)—

22 (i) by redesignating clauses (v), (vi),
23 and (vii), as clauses (vi), (vii), and (viii),
24 respectively; and

1 (ii) by inserting after clause (iv) the
2 following new clause:

3 “(v) student acquisition of 21st Cen-
4 tury skills (such as critical thinking, prob-
5 lem-solving, communication and collabora-
6 tion);”.

23 subparagraphs (A) and (B), respectively;

24 (2) by striking “Each eligible entity” and in-
25 serting the following:

1 “(1) IN GENERAL.—Each eligible entity”; and

2 (3) by adding at the end the following:

3 “(2) DATA SHARING.—Each eligible entity receiving
4 a grant under this chapter shall, to the extent feasible,
5 enter into data-sharing agreements with other organiza-
6 tions or agencies so as to provide for shared access to in-
7 formation on student progress and success (consistent
8 with the requirements of subpart 4 of part C of the Gen-
9 eral Education Provisions Act (20 U.S.C. 1232f et seq.)),
10 integrated planning and joint review of the data, and co-
11 ordinated adjustments in program strategies and activities
12 in response to changes in student needs or to new chal-
13 lenges.”.

14 (c) APPLICATIONS.—Section 404C(a)(2) of the High-
15 er Education Act of 1965 (20 U.S.C. 1070a–23(a)(2)) is

1 “(i) joint planning and implementa-
2 tion;

3 “(ii) shared professional development
4 designed to improve the effectiveness of
5 school, community partner, and other
6 staff;

7 “(iii) development and implementation
8 of shared data systems that support pro-
9 gram improvement and the improvement of
10 program outcomes; and

11 “(iv) the alignment and coordination
12 of local educational agency, school, commu-
13 nity partner, and other partnership mem-

19 school, institution of higher education, nonprofit or-
20 ganization, and community partner staff, develop-
21 ment and implementation of shared data systems
22 that support program improvement and the improve-
23 ment of program outcomes, and the alignment and
24 coordination of, as applicable, school, institution of

1 higher education, nonprofit organization, and com-
2 munity partner goals, activities, and training; and

3 “(B) with the involvement of one or more inter-
4 mediary organizations that assist the grantee by
5 training staff, providing technical assistance that is
6 designed to ensure continuous improvement, helping
7 to ensure accountability for results, and helping to
8 ensure that program funds flow quickly and effec-
9 tively to effective service providers and activities.

10 “(3) DATA SHARING.—Each such program shall in-
11 clude the implementation of one or more data-sharing
12 agreements that between the grantee and other organiza-
13 tions or agencies that provide for shared access to infor-
14 mation on student progress and success (consistent with
15 the requirements of subpart 4 of part C of the General
16 Education Provisions Act (20 U.S.C. 1232f et seq.)), inte-
17 grated planning and joint review of the data, and coordi-
18 nated adjustments in program strategies and activities in
19 response to changes in student needs or to new chal-
20 lenges.”.
