## A BILL

To amend the Native American Programs Act of 1974 to reauthorize a provision to ensure the survival and continuing vitality of Native American languages.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. REAUTHORIZATION OF NATIVE AMERICAN LAN-**  
 2 **GUAGES PROGRAM.**

3 Section 816(e) of the Native American Programs Act  
 4 of 1974 (42 U.S.C. 2992d(e)) is amended by striking  
 5 “2008, 2009, 2010, 2011, and 2012” and inserting “2015  
 6 through 2019”.

7 **SECTION 1. SHORT TITLE.**

8 *This Act may be cited as the “Native American Lan-*  
 9 *guages Reauthorization Act of 2014”.*

10 **SEC. 2. NATIVE AMERICAN LANGUAGES GRANT PROGRAM.**

11 *Section 803C of the Native American Programs Act*  
 12 *of 1974 (42 U.S.C. 2991b–3) is amended—*

13 *(1) in subsection (b)(7)—*

14 *(A) in subparagraph (A)(i), by striking*  
 15 *“10” and inserting “5”; and*

16 *(B) in subparagraph (B)(i), by striking*  
 17 *“15” and inserting “10”; and*

18 *(2) in subsection (e)(2)—*

19 *(A) by striking “or 3-year basis” and in-*  
 20 *serting “3-year, 4-year, or 5-year basis”; and*

21 *(B) by inserting “, 4-year, or 5-year” after*  
 22 *“on a 3-year”.*

23 **SEC. 3. REAUTHORIZATION OF NATIVE AMERICAN LAN-**  
 24 **GUAGES PROGRAM.**

25 *Section 816(e) of the Native American Programs Act*  
 26 *of 1974 (42 U.S.C. 2992d(e)) is amended by striking “2008,*

1 *2009, 2010, 2011, and 2012” and inserting “2015 through*  
2 *2019”.*

Amend the title so as to read: “A bill to amend the Native American Programs Act of 1974 to provide flexibility and reauthorization to ensure the survival and continuing vitality of Native American languages.”.
