A BILL

To amend the Reclamation Projects Authorization and Adjustment Act of 1992 to require the Secretary of the Interior, acting through the Bureau of Reclamation, to take actions to improve environmental conditions in the vicinity of the Leadville Mine Drainage Tunnel in Lake County, Colorado, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Leadville Mine Drain-
 5 age Tunnel Act of 2010”.

6 **SEC. 2. TUNNEL MAINTENANCE.**

7 Section 705 of the Reclamation Projects Authoriza-
 8 tion and Adjustment Act of 1992 (Public Law 102–575;
 9 106 Stat. 4656) is amended to read as follows:

10 **“SEC. 705. TUNNEL MAINTENANCE.**

11 “The Secretary shall take such steps to repair and
 12 maintain the structural integrity of the Leadville Mine
 13 Drainage Tunnel as may be necessary to maintain the
 14 Leadville Mine Drainage Tunnel in safe condition and to
 15 preclude uncontrolled release of water.”.

16 **SEC. 3. WATER QUALITY RESTORATION.**

17 (a) IN GENERAL.—Section 708(a) of the Reclamation
 18 Projects Authorization and Adjustment Act of 1992 (Pub-
 19 lic Law 102–575; 106 Stat. 4657) is amended—

20 (1) by striking “(a) The Secretary” and insert-
 21 ing the following:

22 “(a) IN GENERAL.—

23 “(1) AUTHORIZATION.—The Secretary”;

24 (2) by striking “Neither” and inserting the fol-
 25 lowing:

1 “(2) LIABILITY.—Neither”;

2 (3) by striking “The Secretary shall have” and
3 inserting the following:

4 “(3) FACILITIES COVERED UNDER OTHER
5 LAWS.—

6 “(A) IN GENERAL.—Except as provided in
7 subparagraph (B), the Secretary shall have”;

8 (4) by inserting after “Recovery Act.” the fol-
9 lowing:

10 “(B) RECLAMATION TREATMENT PLANT.—

11 The Secretary may treat water delivered
12 through the Leadville Mine Drainage Tunnel
13 (referred to in this paragraph as the ‘Tunnel’),
14 including—

15 “(i) surface water diverted into the
16 Tunnel; or

17 “(ii) water collected by the dewatering
18 relief well installed in June of 2008.

19 “(3) AUTHORIZATION OF SECRETARY.—The
20 Secretary may—

21 “(A) improve and expand the Reclamation
22 Treatment Plant; and

23 “(B) develop processes under which the
24 treatment of any water in the Treatment Plant
25 (excluding historical flows through the Tunnel

1 and water collected by the dewatering relief well
 2 installed in June of 2008) could be made a re-
 3 imburseable expense.

4 “(4) DUTY OF SECRETARY.—If the Adminis-
 5 trator of the Environmental Protection Agency pro-
 6 poses to amend or issue a new Record of Decision
 7 for operable unit 6, the Administrator shall consult
 8 with the Secretary on each feature of the proposed
 9 new or amended Record of Decision that may re-
 10 quire alterations to, or otherwise affect, the oper-
 11 ation or maintenance of the Tunnel or Reclamation
 12 Treatment Plant.”; and

13 (5) by striking “For the purpose of” and insert-
 14 ing the following:

15 “(5) DEFINITION OF UPPER ARKANSAS RIVER
 16 BASIN.—In”.

17 (b) AUTHORIZATION OF APPROPRIATIONS.—Section
 18 708(f) of the Reclamation Projects Authorization and Ad-
 19 justment Act of 1992 (Public Law 102-575; 106 Stat.
 20 4657) is amended by striking “sections 707 and 708” and
 21 inserting “this section and sections 705 and 707”.

22 (c) CONFORMING AMENDMENT.—The table of con-
 23 tents of title VII of the Reclamation Projects Authoriza-
 24 tion and Adjustment Act of 1992 (Public Law 102-575;

1 106 Stat. 4601) is amended by striking the item relating
 2 to section 705 and inserting the following:

“Sec. 705. Tunnel maintenance.”.

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Leadville Mine Drainage*
 5 *Tunnel Act of 2010.”.*

6 **SEC. 2. TUNNEL MAINTENANCE; OPERATION AND MAINTENANCE.**
 7 **NANCE.**

8 *Section 703 of the Reclamation Projects Authorization*
 9 *and Adjustment Act of 1992 (Public Law 102-575; 106*
 10 *Stat. 4656) is amended to read as follows:*

11 **“SEC. 703. TUNNEL MAINTENANCE; OPERATION AND MAINTENANCE.**
 12 **TENANCE.**

13 *“(a) LEADVILLE MINE DRAINAGE TUNNEL.—The Sec-*
 14 *retary shall take any action necessary to maintain the*
 15 *structural integrity of the Leadville Mine Drainage Tun-*
 16 *nel—*

17 *“(1) to maintain public safety; and*

18 *“(2) to prevent an uncontrolled release of water.*

19 *“(b) WATER TREATMENT PLANT.—*

20 *“(1) IN GENERAL.—Subject to section 705, the*
 21 *Secretary shall be responsible for the operation and*
 22 *maintenance of the water treatment plant authorized*
 23 *under section 701, including any sludge disposal au-*
 24 *thorized under this title.*

1 “(2) *AUTHORITY TO OFFER TO ENTER INTO CON-*
 2 *TRACTS.—In carrying out paragraph (1), the Sec-*
 3 *retary may offer to enter into 1 or more contracts*
 4 *with any appropriate individual or entity for the*
 5 *conduct of any service required under paragraph*
 6 *(1).”.*

7 **SEC. 3. REIMBURSEMENT.**

8 *Section 705 of the Reclamation Projects Authorization*
 9 *and Adjustment Act of 1992 (Public Law 102-575; 106*
 10 *Stat. 4656) is amended—*

11 (1) *by striking “The treatment plant” and in-*
 12 *serting the following:*

13 “(a) *IN GENERAL.—Except as provided in subsection*
 14 *(b), the treatment plant”;* and

15 (2) *by adding at the end the following:*

16 “(b) *EXCEPTION.—The Secretary may—*

17 (1) *enter into an agreement with any other en-*
 18 *tity or government agency to provide funding for an*
 19 *increase in any operation, maintenance, replacement,*
 20 *capital improvement, or expansion cost that is nec-*
 21 *essary to improve or expand the treatment plant; and*

22 (2) *upon entering into an agreement under*
 23 *paragraph (1)—*

24 (A) *make any necessary capital improve-*
 25 *ment to or expansion of the treatment plant; and*

1 “(B) treat flows that are conveyed to the
2 treatment plant, including any—

3 “(i) surface water diverted into the
4 Leadville Mine Drainage Tunnel; and

5 “(ii) water collected by the dewatering
6 relief well installed in June 2008.”.

7 **SEC. 4. USE OF LEADVILLE MINE DRAINAGE TUNNEL AND**
8 **TREATMENT PLANT.**

9 Section 708(a) of the Reclamation Projects Authoriza-
10 tion and Adjustment Act of 1992 (Public Law 102–575; 106
11 Stat. 4657) is amended—

12 (1) by striking “(a) The Secretary” and insert-
13 ing the following:

14 “(a) *IN GENERAL.*—

15 “(1) *AUTHORIZATION.*—The Secretary”;

16 (2) by striking “Neither” and inserting the fol-
17 lowing:

18 “(2) *LIABILITY.*—Neither”;

19 (3) by striking “The Secretary shall have” and
20 inserting the following:

21 “(3) *FACILITIES COVERED UNDER OTHER*
22 *LAWS.*—

23 “(A) *IN GENERAL.*—Except as provided in
24 subparagraph (B), the Secretary shall have”;

1 (4) by inserting after “Recovery Act.” the fol-
2 lowing:

3 “(B) *EXCEPTION.*—If the Administrator of
4 the Environmental Protection Agency proposes to
5 amend or issue a new Record of Decision for op-
6 erable unit 6 of the California Gulch National
7 Priorities List Site, the Administrator shall con-
8 sult with the Secretary with respect to each fea-
9 ture of the proposed new or amended Record of
10 Decision that may require any alteration to, or
11 otherwise affect the operation and maintenance
12 of—

13 “(i) the Leadville Mine Drainage Tun-
14 nel; or

15 “(ii) the water treatment plant author-
16 ized under section 701.

17 “(4) *AUTHORITY OF SECRETARY.*—The Secretary
18 may implement any improvement to, or new oper-
19 ation of, the Leadville Mine Drainage Tunnel or
20 water treatment plant authorized under section 701
21 as a result of a new or amended Record of Decision
22 only upon entering into an agreement with the Ad-
23 ministrator of the Environmental Protection Agency
24 or any other entity or government agency to provide
25 funding for the improvement or new operation.”; and

1 (5) by striking “For the purpose of” and insert-
2 ing the following:

3 “(5) *DEFINITION OF UPPER ARKANSAS RIVER*
4 *BASIN.—In*”.

5 **SEC. 5. AUTHORIZATION OF APPROPRIATIONS.**

6 Section 708(f) of the Reclamation Projects Authoriza-
7 tion and Adjustment Act of 1992 (Public Law 102-575; 106
8 Stat. 4657) is amended by striking “sections 707 and 708”
9 and inserting “this section and sections 703, 705, and 707”.

10 **SEC. 6. CONFORMING AMENDMENT.**

11 The table of contents of title VII of the Reclamation
12 Projects Authorization and Adjustment Act of 1992 (Public
13 Law 102-575; 106 Stat. 4601) is amended by striking the
14 item relating to section 703 and inserting the following:

 “Sec. 703. Tunnel maintenance; operation and maintenance.”.
