Authorizing expenditures by the Select Committee on Intelligence.

Mrs. FEINSTEIN, from the Select Committee on Intelligence, reported the following original resolution; which was referred to the Committee on Rules and Administration

---

## RESOLUTION

Authorizing expenditures by the Select Committee on  
Intelligence.

1       *Resolved*, That, in carrying out its powers, duties, and  
2 functions under the Standing Rules of the Senate, in ac-  
3 cordance with its jurisdiction under Rule XXV of such  
4 rules, including holding hearings, reporting such hearings,  
5 and making investigations as authorized by paragraphs 1  
6 and 8 of Rule XXVI of the Standing Rules of the Senate,  
7 the Select Committee on Intelligence is authorized from  
8 October 1, 2013, through September 30, 2014, and Octo-  
9 ber 1, 2014, through February 28, 2015, in its discretion  
10 (1) to make expenditures from the contingent fund of the

1 Senate, (2) to employ personnel, and (3) with the prior  
2 consent of the Government department or agency con-  
3 cerned and the Committee on Rules and Administration,  
4 to use on a reimbursable or non-reimbursable basis the  
5 services of personnel of any such department or agency.

6       SEC. 2. (a) The expenses of the committee for the  
7 period October 1, 2013, through September 30, 2014,  
8 under this resolution shall not exceed \$5,516,196 of which  
9 amount not to exceed \$17,144 may be expended for the  
10 procurement of the services of individual consultants, or  
11 organizations thereof (as authorized by section 202(i) of  
12 the Legislative Reorganization Act of 1946 (2 U.S.C.  
13 72a(i))).

14       (b) For the period October 1, 2014, through Feb-  
15 ruary 28, 2015, expenses for the committee under this res-  
16 olution shall not exceed \$2,298,415, of which amount not  
17 to exceed \$7,144 may be expended for the procurement  
18 of the services of individual consultants, or organizations  
19 thereof (as authorized by section 202(i) of the Legislative  
20 Reorganization Act of 1946 (2 U.S.C. 72a(i))).

21       SEC. 3. The committee shall report its findings, to-  
22 gether with such recommendations for legislation as it  
23 deems advisable, to the Senate at the earliest practicable  
24 date, but not later than February 28, 2015.

1        SEC. 4. Expenses of the committee under this resolu-  
2 tion shall be paid from the contingent fund of the Senate  
3 upon vouchers approved by the chairman of the com-  
4 mittee, except that vouchers shall not be required (1) for  
5 the disbursement of salaries of employees paid at an an-  
6 nual rate, or (2) for the payment of telecommunications  
7 provided by the Office of the Sergeant at Arms and Door-  
8 keeper, United States Senate, or (3) for the payment of  
9 stationery supplies purchased through the Keeper of the  
10 Stationery, United States Senate, or (4) for payments to  
11 the Postmaster, United States Senate, or (5) for the pay-  
12 ment of metered charges on copying equipment provided  
13 by the Office of the Sergeant at Arms and Doorkeeper,  
14 United States Senate, or (6) for the payment of Senate  
15 Recording and Photographic Services, or (7) for payment  
16 of franked and mass mail costs by the Sergeant at Arms  
17 and Doorkeeper, United States Senate.

18        SEC. 5. There are authorized such sums as may be  
19 necessary for agency contributions related to the com-  
20 pensation of employees of the committee from October 1,  
21 2013, through September 30, 2014, and October 1, 2014,  
22 through February 28, 2015, to be paid from the Appro-  
23 priations account for “Expenses of Inquiries and Inves-  
24 tigation”.
