## 2023 ASSEMBLY BILL 981

January 19, 2024 – Introduced by Representatives STUBBS, GOEBEN, BEHNKE, CONLEY, CONSIDINE, DITTRICH, DRAKE, EMERSON, GUNDRUM, HURD, KITCHENS, MADISON, MOORE OMOKUNDE, MURPHY, O'CONNOR, OHNSTAD, PALMERI and SINICKI, cosponsored by Senators L. JOHNSON, TAYLOR and WIRCH. Referred to Committee on Jobs, Economy and Small Business Development.

## Analysis by the Legislative Reference Bureau

This bill requires the Department of Justice, in consultation with the Technical College System Board, the Department of Safety and Professional Services, and the Cosmetology Examining Board, to identify and establish industry specific materials for use in providing instruction to students in schools of barbering, schools of cosmetology, and specialty schools in the recognition and reporting of human trafficking. Specialty schools are establishments that offer instruction in aesthetics, electrology, or manicuring. Further, under the bill, DSPS and the Cosmetology Examining Board must require that schools of barbering, schools of cosmetology, and specialty schools provide instruction on the dynamics of exploitation including vulnerabilities that put people at risk of being trafficked and how to recognize and report suspected human trafficking as identified by DOJ under the bill.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

2	165.715 Prevention of human trafficking. The department of justice, in
3	consultation with the technical college system board, the department of safety and
4	professional services, and the cosmetology examining board, shall, no later than one
5	year following the effective date of this section [LRB insert date], identify and
6	establish industry specific materials for use in providing instruction to students in
7	schools of barbering licensed under s. 440.62 (3) (ag), schools of cosmetology licensed
8	under s. 440.62 (3) (ar), and specialty schools licensed under s. 440.62 (4) in the
9	recognition and reporting of human trafficking, including both sex trafficking and
10	labor trafficking.
11	<b>SECTION 2.</b> 440.62 (3) (ag) 4m. of the statutes is created to read:
12	440.62 (3) (ag) 4m. Satisfies the requirements for schools of barbering
13	established under sub. (5) (b) 2m.
14	SECTION 3. 440.62 (3) (ar) 7m. of the statutes is created to read:
15	440.62 (3) (ar) 7m. Satisfies the requirements for schools of cosmetology
16	established under sub. (5) (b) 1m.
17	<b>SECTION 4.</b> 440.62 (4) (a) 2m. of the statutes is created to read:
