7	Cullen was elected to and served on the Janesville Public School Board from 2007 to
8	2010; and
9	Whereas, Timothy F. Cullen has served or continues to serve on the Les Aspin
10	School of Government Board of Visitors, the Board of Everyone Cooperating to Help
11	Others (ECHO), the Janesville Teacher Diversity Board, the Janesville YMCA
12	Board, and the Big Brothers Board of Directors; and
