FISCAL NOTE ANALYSIS

STATE OF ALASKA 2019 LEGISLATIVE SESSION

Analysis

Passage of this legislation would have no immediate fiscal impact on the division but would require repealing or amending 6 AAC 25.650. In order to have the regulations in effect for the 2020 primary election, the regulation project would need to be complete by April 30, 2020.
The division anticipates the number of vote by mail voters would gradually increase over time. It is possible the number of by mail voters could grow to a point where the division would not be able to comply with this statute within the current budget. The division would then need to procure the services of an outside vendor to process and mail ballots. It would not be known until that time what the additional fiscal impact would be to the division.
