## **A BILL**

# FOR AN ACT ENTITLED

- 1 "An Act relating to the practice of naturopathy; establishing the Naturopathy Board;
- 2 relating to the licensure of naturopaths; relating to disciplinary sanctions for
- 3 naturopaths; relating to the Department of Commerce, Community, and Economic
- 4 Development; and providing for an effective date."

## 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:
