FOR AN ACT ENTITLED

1 "An Act relating to questionnaires and surveys administered in the public schools."

2 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

- * **Section 1.** AS 14.03.110(a) is repealed and reenacted to read:
 - (a) A school district or an employee of a school district may not administer or permit administration of a questionnaire or survey to a class or student unless written permission is obtained from the student's parent or legal guardian. This subsection does not apply to a questionnaire or survey that is anonymous or that concerns a matter of public record or public observation.

 - (b) If a school district or an employee of a school district administers or permits the administration of an anonymous questionnaire or survey, written permission from a student's parent or legal guardian is not required, but the school district shall provide each student's parent or legal guardian the opportunity to submit to the school principal a written denial of permission to take the questionnaire or survey.
