A BILL

FOR AN ACT ENTITLED

- 1 "An Act relating to unemployment benefits; and providing for an effective date."
- 2 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:
- * Section 1. The uncodified law of the State of Alaska is amended by adding a new section
- 4 to read:
- 5 UNEMPLOYMENT INSURANCE: BENEFIT OUALIFICATION AND WAITING
- 6 WEEK. (a) The limitations under AS 23.20.375(b) do not apply to benefits payable to an
- 7 insured worker under AS 23.20 (Alaska Employment Security Act) who is otherwise entitled
- 8 to receive waiting-week credit or benefits under AS 23.20.375(a). In this subsection, "insured
- 9 worker" has the meaning given in AS 23.20.520.
- 10 (b) The provision of a benefit as permitted by this section is not a violation of 11 AS 23.20.500.
- 12 (c) The commissioner of labor and workforce development shall administer this
- 13 section as required under AS 23.20.005(b) and 23.20.095.
- * Sec. 2. The uncodified law of the State of Alaska is amended by adding a new section to
- 15 read:

- 1 UNEMPLOYMENT INSURANCE: DEPENDENT ALLOWANCE. Notwithstanding
- 2 AS 23.20.350(f) and to the extent consistent with federal law, the allowance for dependents of
- 3 an insured worker under AS 23.20 (Alaska Employment Security Act) who establishes a
- 4 benefit year under AS 23.20.350 is \$75 per week for each dependent. The Department of
- 5 Labor and Workforce Development may not limit the total allowances for dependents paid to
- 6 the insured worker for each week of unemployment. In this section, "dependent" has the
- 7 meaning given in AS 23.20.350(g).
- * Sec. 3. The uncodified law of the State of Alaska is amended by adding a new section to
- 9 read:
- 10 TRANSITION: REGULATIONS. The commissioner of labor and workforce
- development may adopt regulations necessary to implement this Act. The regulations are not
- subject to AS 44.62 (Administrative Procedure Act).
- * Sec. 4. Sections 1 and 2 of this Act are repealed December 31, 2021.
- * Sec. 5. The uncodified law of the State of Alaska is amended by adding a new section to
- 15 read:
- 16 RETROACTIVITY. Sections 1 3 of this Act are retroactive to April 1, 2021.
- * Sec. 6. This Act takes effect immediately under AS 01.10.070(c).
