## A BILL

## FOR AN ACT ENTITLED

1 "An Act relating to a parent's right to direct the education of a child; relating to the

duties of the state Board of Education and Early Development, the Department of

3 Education and Early Development, school boards, and school districts; relating to public

4 school curriculum and assessments; relating to compliance with federal education laws;

relating to public school accountability; relating to a statewide assessment plan and

review of education laws and regulations; repealing the minimum expenditure for

instruction for school districts; relating to sex education, human reproductive education,

and human sexuality education; relating to suicide awareness and prevention training;

relating to contracts for student assessments; relating to questionnaires and surveys

10 administered in public schools; relating to physical examinations for teachers; and

11 providing for an effective date."
