A BILL

FOR AN ACT ENTITLED

1 "An Act adding to the powers and duties of the State Commission for Human Rights;

2 and relating to and prohibiting discrimination based on sexual orientation or gender

3 identity or expression."

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

5 * Section 1. AS 18.80.060(a) is amended to read: 6 (a) In addition to the other powers and duties prescribed by this chapter, the 7 commission shall 8 (1) appoint an executive director approved by the governor; 9 (2)hire other administrative staff as may be necessary to the commission's function: 10 11 exercise general supervision and direct the activities of the (3)12 executive director and other administrative staff; 13 (4) accept complaints under AS 18.80.100; 14 (5) study the problems of discrimination in all or specific fields of human relationships, foster through community effort or goodwill, cooperation and
conciliation among the groups and elements of the population of the state, and publish
results of investigations and research as in its judgment will tend to eliminate
discrimination because of race, religion, color, national ancestry, physical or mental
