# FOR AN ACT ENTITLED

1 "An Act relating to the registration of commercial vessels; and providing for an effective 2 date." 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA: 4 \* **Section 1.** AS 05.25.055(i) is amended to read: 5 (i) The following boats are exempt from the numbering and registration 6 provisions of this section: 7 (1) a boat that 8 (A) is not a barge; 9 (B) is operated in this state for a period not exceeding 90 10 consecutive days; and 11 (C) has a current, valid certificate of number issued by another 12 state having a federally approved numbering system;
