FOR AN ACT ENTITLED

- "An Act relating to allowable absences for a permanent fund dividend; and providing
 for an effective date."
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:
- *** Section 1.** AS 43.23.005(a) is amended to read:
- 5 (a) An individual is eligible to receive one permanent fund dividend each year
- in an amount to be determined under AS 43.23.025 if the individual
- 7 (1) applies to the department;
- 8 (2) is a state resident on the date of application;
- 9 (3) was a state resident during the entire qualifying year;
- 10 (4) has been physically present in the state for at least <u>seven</u> [72]
- 11 consecutive <u>days</u> [HOURS] at some time during the prior two years before the current
- dividend year;
- 13 (5) is
- 14 (A) a citizen of the United States;

2	United States;
3	(C) an alien with refugee status under federal law; or
4	(D) an alien that has been granted asylum under federal law;

8	selective service registration requirements imposed under 50 U.S.C. App. 453
9	(Military Selective Service Act), if those requirements were applicable to the
10	individual, or has come into compliance after being notified of the lack of compliance.
