FOR AN ACT ENTITLED

1 "An Act relating to a voluntary preference for members of the national guard and

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

AS 18.80.200 is amended by adding a new subsection to read: 5 (c) Nothing in this chapter is intended to prohibit a private employer from 6 granting an employment preference to a member of the national guard or a veteran 7 when hiring an employee. In this subsection, (1) "member of the national guard" means a person presently serving 8 9 as a member in good standing in the national guard; 10 (2) "veteran" means a person who was discharged under honorable 11 conditions from service in 12 (A) the armed forces of the United States; 13 (B) a reserve unit of the armed forces of the United States; 14 (C) the Alaska Territorial Guard;
