FOR AN ACT ENTITLED

1 "An Act relating to the Public Employees' Retirement System of Alaska and the 2 teachers' retirement system; providing certain employees an opportunity to choose 3 between the defined benefit and defined contribution plans of the Public Employees' 4 Retirement System of Alaska and the teachers' retirement system; and providing for an 5 effective date." 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA: 7 * Section 1. AS 14.25.009 is repealed and reenacted to read: 8 Sec. 14.25.009. Applicability of AS 14.25.009 - 14.25.220. (a) The provisions 9 of AS 14.25.009 - 14.25.220 apply to teachers who are eligible to be members of the 10 teachers' retirement system under AS 14.25.009 - 14.25.220 and are not members of 11 the defined contribution retirement plan under AS 14.25.310 - 14.25.590. 12 (b) An employer that participates in the plan shall also participate in the

13 defined contribution retirement plan under AS 14.25.310 - 14.25.590.
