- 5 (e) A legislative body may hold an executive session only for the reasons
- 6 permitted under Rule 22(b), Uniform Rules of the Alaska State Legislature, and
- 7 in accordance with the procedure applicable to committees under Rule 22(c),
- 8 Uniform Rules of the Alaska State Legislature. In cases where there are conflicts
- 9 between the open meetings guidelines established in this section [THESE
- 10 GUIDELINES] and the uniform rules [ADOPTED BY THE ALASKA STATE
- 11 LEGISLATURE], the uniform rules prevail.
