# FOR AN ACT ENTITLED

1 "An Act relating to the compensation of certain public officials, officers, and employees

2 not covered by collective bargaining agreements; and providing for an effective date."

## **3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:**

Public officers and permanent and 4 temporary employees in the executive branch of the state government, other than the governor 5 and lieutenant governor, who are in the exempt service under AS 39.25.110, are not members 6 of a collective bargaining unit established under AS 23.40.070 - 23.40.260 (Public 7 Employment Relations Act), and are not otherwise covered by AS 39.27.011(a), are entitled 8 to receive salaries comparable to those received by classified and partially exempt employees 9 of the executive branch under AS 39.27.011(a), as repealed and reenacted by sec. 1 of this 10 Act, and under AS 39.27.011(e) and (f), as amended by secs. 2 and 3 of this Act;

13 SALARY ADJUSTMENTS FOR CERTAIN EMPLOYEES OF THE JUDICIAL 14 BRANCH. (a) Permanent and temporary employees and magistrates in the judicial branch of 15 the state government, other than justices and judges, who are not members of a collective bargaining unit established under AS 23.40.070 - 23.40.260 (Public Employment Relations 16 17 Act), and are not otherwise covered by AS 39.27.011(a), are entitled to receive salary 18 adjustments comparable to those received by classified and partially exempt employees of the 19 executive branch under AS 39.27.011(a), as repealed and reenacted by sec. 1 of this Act, and 20 under AS 39.27.011(e) and (f), as amended by secs. 2 and 3 of this Act.

(b) Justices of the supreme court and judges of the court of appeals and the superior
and district courts are entitled to receive salary adjustments provided for in secs. 1 - 3 of this
Act, in accordance with AS 22.05.140(d), AS 22.07.090(c), AS 22.10.190(d), and
AS 22.15.220(e).

\* Sec. 6. The uncodified law of the State of Alaska is amended by adding a new section to
 read:

SALARY INCREASES FOR CERTAIN EMPLOYEES OF THE UNIVERSITY OF
ALASKA. The employees of the University of Alaska who are not members of a collective
bargaining unit are entitled to receive salary increases in accordance with the compensation
policy of the Board of Regents of the University of Alaska.
