**A BILL**

**FOR AN ACT ENTITLED**

1 **"An Act adding state land to Kachemak Bay State Park; relating to Tutka Bay Lagoon**  
2 **and the Tutka Bay Lagoon Hatchery; and providing for an effective date."**

3 **BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:**

4 **\* Section 1.** AS 41.21.131(a) is amended to read:

5 (a) The presently state-owned land and water, and all that acquired in the  
6 future by the state, lying within the parcels described in this section are designated as  
7 the Kachemak Bay State Park. In order to protect and preserve this land and water for  
8 its unique and exceptional scenic value, the park is established and shall be managed  
9 as a scenic park. The land and water lying within the following described parcels is  
10 reserved from all uses incompatible with its primary function as a scenic park and is  
11 assigned to the department for control, development, and maintenance:

21                   (d) The following land and water, commonly known as Tutka Bay Lagoon,  
 22                   and the land on which the Tutka Bay Lagoon Hatchery is located, containing  
 23                   approximately 123.45 acres of land, is excepted from (a) and (b) of this section, shall  
 24                   be managed by the department, and is not part of the Kachemak Bay State Park:  
 25                   commencing at control point no. 99, a 2-inch aluminum cap on 5/8-inch rebar, marked  
 26                   CP 99, LS 4469, 2012, at latitude 59 degrees 26 minutes 09.172 seconds North and  
 27                   longitude 151 degrees 24 minutes 52.651 seconds West; from which control point no.  
 28                   101, a 2-inch aluminum cap on 5/8-inch rebar, marked CP 101, LS 4469, 2012, at  
 29                   latitude 59 degrees 26 minutes 12.651 seconds North and longitude 151 degrees 24  
 30                   minutes 50.806 seconds West bears north 16 degrees 20 minutes 07 seconds East, a  
 31                   distance of 365.84 feet; thence south 17 degrees 36 minutes 32 seconds East, a

1 distance of 649.17 feet to the south corner no. 1 of the parcel, an unmonumented  
2 position at latitude 59 degrees 26 minutes 03.12 seconds North and longitude 151  
3 degrees 24 minutes 48.60 seconds West, and the true point of beginning of the herein

7 West; thence north 63 degrees 25 minutes 05 seconds West, a distance of 1194.84 feet  
8 to corner no. 3, an unmonumented position at latitude 59 degrees 26 minutes 20.04  
9 seconds North and longitude 151 degrees 25 minutes 35.76 seconds West; thence  
10 north 62 degrees 18 minutes 23 seconds West, a distance of 1476.37 feet to corner no.  
11 4, an unmonumented position at latitude 59 degrees 26 minutes 26.52 seconds North  
12 and longitude 151 degrees 26 minutes 01.32 seconds West; thence north 29 degrees 51  
13 minutes 17 seconds East, a distance of 582.91 feet to corner no. 5, an unmonumented  
14 position at latitude 59 degrees 26 minutes 31.56 seconds North and longitude 151  
15 degrees 25 minutes 55.92 seconds West; thence south 81 degrees 46 minutes 26  
16 seconds East, a distance of 1500.30 feet to corner no. 6, an unmonumented position at  
17 latitude 59 degrees 26 minutes 29.76 seconds North and longitude 151 degrees 25  
18 minutes 27.12 seconds West; thence south 67 degrees 27 minutes 47 seconds East, a  
19 distance of 3217.16 feet to corner no. 7, an unmonumented position at latitude 59  
20 degrees 26 minutes 18.24 seconds North and longitude 151 degrees 24 minutes 29.16  
21 seconds West; thence south 34 degrees 26 minutes 11 seconds West, a distance of  
22 1834.95 feet to corner no. 1, the point of beginning.

23 \* **Sec. 3.** AS 41.21.131(d) is repealed.

24 \* **Sec. 4.** The uncodified law of the State of Alaska is amended by adding a new section to  
25 read:

26 **CONDITIONAL EFFECT; NOTIFICATION.** (a) Section 3 of this Act takes effect  
27 only if, for a period of three years, the Department of Fish and Game does not operate or  
28 contract with another party to operate the Tutka Bay Lagoon Hatchery.

29 (b) The commissioner of natural resources shall notify the revisor of statutes in  
30 writing within 30 days after the three-year period has elapsed as provided in (a) of this  
31 section.

1     \* **Sec. 5.** If sec. 3 of this Act takes effect under sec. 4 of this Act, it takes effect on the day  
2 after the date on which the commissioner of natural resources makes the notification to the  
3 revisor of statutes under sec. 4 of this Act.

4     \* **Sec. 6.** Except as provided in sec. 5 of this Act, this Act takes effect immediately under  
5 AS 01.10.070(c).
