1 * **Sec. 7. PURPOSE.** In accordance with AS 37.14.003 and 37.14.005, the appropriations
2 made in this Act are for the state's integrated comprehensive mental health program.

3 * **Sec. 8. NONGENERAL FUND RECEIPTS.** (a) Alaska Mental Health Trust Authority
4 authorized receipts (AS 37.14.036) or administration receipts (AS 37.14.036) that exceed the
5 amounts appropriated in this Act are appropriated conditioned upon compliance with the
6 program review provisions of AS 37.07.080(h).

7 (b) If Alaska Mental Health Trust Authority authorized receipts (AS 37.14.036) or
8 administration receipts (AS 37.14.036) fall short of the estimates used as the basis of the
9 appropriation, the affected appropriation is reduced by the amount of the shortfall in receipts.

10 * **Sec. 9. SALARY AND BENEFIT ADJUSTMENTS.** (a) The appropriations made in sec.
11 1 of this Act include amounts for salary and benefit adjustments for public officials, officers,
12 and employees of the executive branch, Alaska Court System employees, employees of the
13 legislature, and legislators and to implement the monetary terms for the fiscal year ending
14 June 30, 2026, of the following ongoing collective bargaining agreements:

15 (1) Public Safety Employees Association, representing the regularly
16 commissioned public safety officers unit members within the Department of Transportation
17 and Public Facilities;

18 (2) Public Safety Employees Association, representing the regularly
19 commissioned public safety officers unit members within the Department of Public Safety;

20 (3) Public Employees Local 71, for the labor, trades, and crafts unit;

21 (4) Alaska Public Employees Association, for the supervisory unit;

22 (5) Alaska Correctional Officers Association, representing the correctional
23 officers unit;

24 (6) Teachers' Education Association of Mt. Edgecumbe, representing the
25 teachers of Mt. Edgecumbe High School;

26 (7) Alaska Vocational Technical Center Teachers' Association, National
27 Education Association, representing the employees of the Alaska Vocational Technical
28 Center;

29 (8) International Organization of Masters, Mates, and Pilots, representing the
30 masters, mates, and pilots unit.

31 (b) The appropriations made to the University of Alaska in sec. 1 of this Act include

1 amounts for salary and benefit adjustments for the fiscal year ending June 30, 2026, for
 2 university employees who are not members of a collective bargaining unit and to implement
 3 the monetary terms for the fiscal year ending June 30, 2026, of the following collective
 4 bargaining agreements:

- 5 (1) Fairbanks Firefighters Union, IAFF Local 1324;
- 6 (2) Alaska Higher Education Crafts and Trades Employees, Local 6070;
- 7 (3) Alaska Graduate Workers Association/UAW;
- 8 (4) United Academics - American Association of University Professors,
 9 American Federation of Teachers;
- 10 (5) United Academic - Adjuncts - American Association of University
 11 Professors, American Federation of Teachers.

12 (c) If a collective bargaining agreement listed in (a) of this section is not ratified by
 13 the membership of the respective collective bargaining unit, the appropriations made in this
 14 Act applicable to the collective bargaining unit's agreement are adjusted proportionately by
 15 the amount for that collective bargaining agreement, and the corresponding funding source
 16 amounts are adjusted accordingly.

17 (d) If a collective bargaining agreement listed in (b) of this section is not ratified by
 18 the membership of the respective collective bargaining unit and approved by the Board of
 19 Regents of the University of Alaska, the appropriations made in this Act applicable to the
 20 collective bargaining unit's agreement are adjusted proportionately by the amount for that
 21 collective bargaining agreement, and the corresponding funding source amounts are adjusted
 22 accordingly.

23 (e) Appropriations made in sec. 1 of this Act for salary and benefit adjustments as
 24 described in (a) and (b) of this section are for the benefit of the state's integrated
 25 comprehensive mental health program only and do not necessarily affect every group of
 26 noncovered employees or every collective bargaining unit listed in (a) and (b) of this section.

27 * **Sec. 10.** This Act takes effect July 1, 2025.
