A BILL

FOR AN ACT ENTITLED

1 "An Act prohibiting disposable plastic shopping bags; and providing for an effective

2 date."

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

4 * Section 1. AS 46.06 is amended by adding a new section to read:

5 Sec. 46.06.145. Shopping bags. (a) Except as provided in (b) of this section, a 6 retail seller of goods or services may not provide a disposable plastic shopping bag to 7 a purchaser to carry away or protect goods purchased from, or serviced by, the retail 8 seller.

9 (b) The prohibition established in (a) of this section does not apply to a 10 disposable plastic shopping bag that is

(1) used only to contain a product that does not have other packaging,
including bulk grains, fruit, nuts, vegetables, meat, candy, bakery goods, prepared
foods, or other food products or small hardware items;

(2) used only to contain ice;

1	(3) used only to contain or wrap flowers;
2	(4) provided by a pharmacist for the sole purpose of containing
3	prescription drugs;
4	(5) used only to package an unconsumed portion of a bottle of wine in
5	compliance with AS 04.16.120;
6	(6) used only to contain a newspaper;
7	(7) sold in packages containing multiple bags intended for use as
8	garbage, pet waste, or yard waste bags; or
9	(8) a reusable bag.
10	(c) The department may assess an administrative fine against a retail seller that
11	violates (a) of this section. An administrative fine under this subsection may not
12	exceed
13	(1) \$250 for a first violation;
14	(2) \$500 for a second violation within one year; and
15	(3) \$750 for each violation after a second violation within one year.
16	(d) In this section,
17	(1) "disposable plastic shopping bag" means a bag made exclusively or
18	partially of plastic, other than a reusable bag;
19	(2) "retail seller" includes a market, grocery store, convenience store,
20	drug store, or other retail establishment that
21	(A) sells goods to consumers; and
22	(B) is located in a permanent building;
23	(3) "reusable bag" means a bag that
24	(A) is designed and manufactured to withstand repeated use
25	over time;
26	(B) is machine washable or is made from material that can be
27	cleaned and disinfected regularly;
28	(C) if it is made from plastic, is made with plastic that is at
29	least four mils thick; and
30	(D) is designed to have a minimum lifetime of 75 uses.
31	* Sec. 2. This Act takes effect January 1, 2021.
