FOR AN ACT ENTITLED

- "An Act relating to rental vehicles; relating to vehicle rental networks; relating to vehicle rental taxes; relating to the collection of a municipal sales tax for certain vehicle rentals; relating to vehicle rental fees; and providing for an effective date."
 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:
 * Section 1. The uncodified law of the State of Alaska is amended by adding a new section to read:
- 7 SHORT TITLE. This Act may be known as the Vehicle Rental Modernization Act.

- 9 Sec. 43.52.020. Rate of passenger vehicle rental tax. The rate of the tax levied in AS 43.52.010 is

- 13 (2) five percent of the total fees and costs charged for the lease or 14 rental of a passenger vehicle from a vehicle rental individual.

30	vehicle rental network company to collect and pay the municipal sales tax on behalf of
31	a vehicle rental business or vehicle rental individual.

6	or vehicle rental individual electronically. The acceptance of a notice or disclosure is
7	valid until the person affirmatively withdraws acceptance of the notice or disclosure.

19	good faith estimate by the vehicle rental [CAR] business or vehicle rental individual
20	of the average daily cost to the vehicle rental [CAR] business or vehicle rental
21	individual of recovering its actual total annual licensing costs in the state during a
22	calendar year.
23	(b) If the total amount of the vehicle licensing cost recovery fees collected by
24	a vehicle rental [CAR] business or vehicle rental individual during a calendar year
25	exceeds the actual amount of the vehicle rental [CAR] business's or vehicle rental
26	individual's licensing costs during that calendar year, the vehicle rental [CAR]
27	business or vehicle rental individual shall
28	(1) retain the excess amount; and
29	(2) adjust the good faith estimate required by (a) of this section for the
30	next calendar year so that the good faith estimate reflects the excess amount.
31	(c) In addition to the adjustment required by (b) of this section, a vehicle

1	rental [CAR] business or venicle rental individual may adjust its venicle neensing
2	cost recovery fee during the calendar year when the excess vehicle licensing cost
3	recovery fees are collected if the vehicle licensing cost recovery fee otherwise
4	complies with this section.

28	vehicle rentals in the state, but whose primary business is not the rental of
29	vehicles;
30	(9) "vehicle rental network" means a digital network that connects
31	vehicle renters to personal vehicle owners; in this paragraph, "digital network"

1	means any online-enabled application, software, website, or system offered or
2	used by a vehicle rental network company that enables the prearrangement of
3	vehicle rentals with personal vehicle owners.
