FOR AN ACT ENTITLED

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

5 * Section 1. AS 08.64.010 is amended to read:

6 Sec. 08.64.010. Creation and membership of State Medical Board. The 7 governor shall appoint a board of medical examiners, to be known as the State 8 Medical Board, consisting of five physicians licensed in the state and residing in as 9 many separate geographical areas of the state as possible, one physician assistant 10 licensed under AS 08.64.107, one mobile intensive care paramedic licensed under AS 08.64.107, and one person [TWO PERSONS] with no direct financial interest in 11 12 the health care industry. * Sec. 2. 14	* Sec. 6. Except as provided in sec. 5 of this Act, this Act takes effect March 1, 2017.
