FOR AN ACT ENTITLED

- 1 "An Act relating to certain alcoholic beverage licenses and permits; relating to the bond
- 2 requirement for certain alcoholic beverage license holders; and providing for an
- 3 effective date."

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

5 * Section 1. AS 04.11.080 is amended to read:
