## FOR AN ACT ENTITLED

1 "An Act relating to electronic identification cards; relating to electronic drivers' licenses 2 and permits; relating to motor vehicle liability insurance; and providing for an effective 3 date." 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA: 5 \* Section 1. AS 18.65.310(a) is amended to read: 6 (a) Upon payment of a \$15 fee, the department shall issue a physical card 7 identical to the motor vehicle operator's license provided for in AS 28.15.111, except 8 that the card shall be of a different color and shall state in bold type letters across the 9 face of it that it is for identification purposes only. Upon request of a person and upon 10 payment of an additional \$20 fee, the department may issue an identification card 11 under this section that is federally compliant. 12 \* Sec. 2.
