2 the earnings reserve account (AS 37.13.145) to the dividend fund (AS 43.23.045(a)) for the  
3 payment of a supplementary permanent fund dividend and for administrative and associated  
4 costs for the fiscal year ending June 30, 2022.

5     \* **Sec. 5.** LAPSE OF APPROPRIATION. The appropriation made in sec. 4 of this Act is for  
6 the capitalization of a fund and does not lapse.

7     \* **Sec. 6.** RETROACTIVITY. This Act is retroactive to July 1, 2021.

8     \* **Sec. 7.** This Act takes effect immediately under AS 01.10.070(c).
