### A BILL

## FOR AN ACT ENTITLED

- 1 "An Act relating to the membership of the legislative council; and relating to the
- 2 membership of the Legislative Budget and Audit Committee."
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:
- **\* Section 1.** AS 24.20.020 is amended to read:
  - Sec. 24.20.020. Membership. The legislative council is composed of the president of the senate and six other senators appointed by the president, and the speaker of the house of representatives and six other representatives appointed by the speaker. The membership from each house shall include at least one member from the minority [EACH OF THE TWO MAJOR POLITICAL PARTIES]. The minority is entitled to the number of seats on the council that is proportional to the number of minority members compared to the total house membership or to one seat, whichever is greater. In calculating the number of seats the minority is entitled to, fractional numbers that represent the minority proportional entitlement to a seat shall be ignored. The appointing authority in each house shall make and

1	announce the appointment or reappointment of members of the council within 15 days
2	after the convening of the first regular session of each legislature.

Sec. 24.20.161. Membership. The Legislative Budget and Audit Committee is composed of 10 members: the <a href="mailto:chairs">chairs</a> [CHAIRMEN] of the senate and house finance committees</a>
<a href="mailto:cji">cji</a> one member selected from each of the senate and house finance committees and appointed by the president of the senate and the speaker of the house, respectively</a>
<a href="mailto:cji">cji</a> and three members appointed from each house by the respective presiding officer. The <a href="mailto:chair">chair</a> [CHAIRMAN] of the finance committee may choose not to serve on the committee. If this occurs, the presiding officer of the appropriate house shall appoint a replacement from the finance committee. The membership from each house shall include at least one member from <a href="mailto:the minority">the minority</a> [EACH OF THE TWO MAJOR POLITICAL PARTIES]. The committee shall select its own <a href="mailto:chair">chair</a> [CHAIRMAN].

\* Sec. 3. AS 24.20 is amended by adding a new section to read:

#### **Article 4. General Provisions.**

**Sec. 24.20.700. Definition.** In this chapter, "minority" means a group of members who have organized and elected a minority leader and who constitute at least 25 percent of the total house membership.
