A BILL

FOR AN ACT ENTITLED

- 1 "An Act relating to occupational licensing; relating to temporary licenses, permits, and
- 2 certificates; and providing for an effective date."

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF ALASKA:

* **Section 1.** AS 08.01.062 is repealed and reenacted to read:

Sec. 08.01.062. Temporary licenses, permits, and certificates. (a) The department shall issue a temporary license, permit, or certificate under this section to engage in an occupation regulated under this chapter to an individual who holds a corresponding license, permit, or certificate in good standing in another jurisdiction substantially equivalent to the license, permit, or certificate issued in this state, if the individual pays the required fee for a temporary license, permit, or certificate established by the department.

(b) A temporary license or permit issued under this section is valid for one year. A temporary license, permit, or certificate issued under this section allows the temporary license, permit, or certificate holder to temporarily practice the occupation
