This bill would also provide that 15 a member of the U.S. Armed Forces under deployment 16 would not be subject to the time limit. 17 18 A BTLL 19 TO BE ENTITLED 20 AN ACT 21 22 To amend Section 32-6-1, Code of Alabama 1975, relating to driver's license to provide for the period of time 23 24 before expiration of the driver's license in which a person 25 may renew the license; and to provide an exception for certain 26 active duty members of the U.S. Armed Forces. 27 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

Section 1. Section 32-6-1, Code of Alabama 1975, is
 amended to read as follows:

"§32-6-1.

4 "(a) Every person, except those specifically
5 exempted by statutory enactment, shall procure a driver's
6 license before driving a motor vehicle upon the highways of
7 this state. Every new resident of the State of Alabama shall
8 procure an Alabama driver's license within 30 days after
9 establishing residence in this state.

10 "(b) Each original driver's license issued to a person born in a year ending in an odd number shall expire on 11 12 the second anniversary of the licensee's birth date occurring 13 in an odd-numbered calendar year after the date on which the 14 application for the license was filed, and each original 15 driver's license issued to a person born in a year ending with an even number shall expire on the second anniversary of the 16 17 licensee's birth date occurring in an even-numbered calendar year after the date on which the application for the license 18 was filed; provided, that if the license issued would expire 19 in less than 24 months from the date on which the application 20 21 for the license was filed, the expiration date of such license is hereby extended for an additional period of two years. 22 23 After the expiration of an original driver's license, all subsequent renewals shall be for a period of four years from 24 25 the specified expiration date of the immediately preceding 26 license, regardless of when the renewal shall be issued. Every 27 driver's license issued under this article may be renewed at

1 the end of the license period without examination upon 2 application and payment of the fee. For the purpose of renewal of a driver's license, the Department of Public Safety shall 3 4 mail renewal notices to each licensee 30 days after expiration date if the driver's license has not been renewed. A grace 5 6 period of 60 days after expiration date of a driver's license 7 shall exist for the purpose of driver's license renewal and the driver's license shall be valid for this time period. The 8 applicant shall apply for a driver's license anytime during a 9 10 period beginning 30 days 180 days before the expiration date of the then current license until three years after the 11 12 expiration date of the license. Notwithstanding any other 13 provision of law, an active duty member of the U.S. Armed 14 Forces is not subject to the 180-day limit if he or she can 15 show proof to the licensing official that he or she is unable to renew during the 180-day period due to deployment. Failure 16 17 to make application for renewal within the specified time shall result in the applicant being required to take, and 18 successfully pass, a written examination and driving test as 19 administered by the Department of Public Safety. If any 20 21 person's birthday is February 29, the first day of March 22 following shall be regarded as his or her birthday for the 23 purposes of this section.

"(c) The Department of Public Safety shall make
available to any resident of this state who does not hold a
valid Alabama driver's license a nondriver identification card
to be used for identification purposes only. The nondriver

1 identification card shall be issued only upon application of 2 the nondriver and shall be similar to the driver's license; except, that it shall bear the word "nondriver" in prominent 3 4 letters on the face of the identification card. Each nondriver identification card shall bear thereon a distinguishing number 5 6 assigned to the nondriver and a color photograph of the 7 nondriver, as well as the name, birth date, residence address, and a brief description of the nondriver who, for the purpose 8 of identification, shall immediately upon receipt thereof, 9 10 endorse his or her usual signature in ink upon the card in the space provided thereon, unless a facsimile of the nondriver 11 12 signature appears thereon. The same degree of proof of identification required of applicants for driver's licenses in 13 14 this state shall be required of applicants for nondriver identification cards." 15

16 Section 2. This act shall become effective on the 17 first day of the third month following its passage and 18 approval by the Governor, or its otherwise becoming law.
