"Any person individual in this state who votes more than once at any election held in this state, or deposits more than one ballot for the same office as his or her vote at such election, or knowingly another state, or attempts to vote when he or she has knowledge that he or she is not entitled to do so vote, or is guilty of commits any kind of illegal unlawful or fraudulent voting, shall be guilty, upon conviction of a Class C felony."

Section 2. Although this bill would have as its purpose or effect the requirement of a new or increased expenditure of local funds, the bill is excluded from further requirements and application under Amendment 621, now appearing as Section 111.05 of the Official Recompilation of the Constitution of Alabama of 1901, as amended, because the bill defines a new crime or amends the definition of an existing crime.

Section 3. This act shall become effective immediately following its passage and approval by the Governor, or its otherwise becoming law.
