 - Section 3. In addition to all other appropriations heretofore or hereafter made, there is hereby appropriated \$633,985 from the State General Fund to the Supreme Court for the fiscal year ending September 30, 2021 to be used for the updates to the case management and e-filing systems.
 - Section 4. In addition to all other appropriations heretofore or hereafter made, there is hereby appropriated \$4,500,000 from the State General Fund to the Office of Information Technology for the fiscal year ending September 30, 2021 to be used for cybersecurity.
 - Section 5. In addition to all other appropriations heretofore or hereafter made, there is hereby appropriated \$150,000 from the State Board of Dietetics/Nutrition Fund to

the Alabama State Board of Examiners for Dietetics/Nutrition 1 Practice for the fiscal year ending September 30, 2021. 2 Section 6.
