8 SYNOPSIS: This bill would propose an amendment to the
9 Constitution of Alabama of 1901, to prohibit the
10 election of a city or county superintendent of
11 education in the state to a term that extends
12 beyond December 31, 2020, and, commencing January
13 1, 2021, to require all city and county
14 superintendents of education to be appointed by the
15 local board of education.

21 To propose an amendment to the Constitution of
22 Alabama of 1901, to prohibit the election of a city or county
23 superintendent of education in the state to a term that
24 extends beyond December 31, 2020, and, commencing January 1,
25 2021, to require all city and county superintendents of
26 education to be appointed by the local board of education
27 pursuant to general law.

1 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

2 Section 1. The following amendment to the
3 Constitution of Alabama of 1901, as amended, is proposed and
4 shall become valid as a part thereof when approved by a
5 majority of the qualified electors voting thereon and in
6 accordance with Sections 284, 285, and 287 of the Constitution
7 of Alabama of 1901, as amended:

8 PROPOSED AMENDMENT

9 (a) No individual may be elected to serve a term of
10 office as city superintendent of education or county
11 superintendent of education which extends beyond December 31,
12 2020. Any elected city or county superintendent of education
13 who is serving in that position on December 31, 2020, shall
14 vacate office on that date.

15 (b) Commencing January 1, 2021, all city and county
16 superintendents of education shall be appointed by the local
17 board of education pursuant to general law.

18 Section 2. An election upon the proposed amendment
19 shall be held in accordance with Sections 284 and 285 of the
20 Constitution of Alabama of 1901, now appearing as Sections 284
21 and 285 of the Official Recompilation of the Constitution of
22 Alabama of 1901, as amended, and the election laws of this
23 state.

24 Section 3. The appropriate election official shall
25 assign a ballot number for the proposed constitutional
26 amendment on the election ballot and shall set forth the

1 following description of the substance or subject matter of
2 the proposed constitutional amendment:

3 "Proposing an amendment to the Constitution of
4 Alabama of 1901, relating to city and county superintendents
5 of education; to prohibit the election of a city or county
6 superintendent of education in the state to a term that
7 extends beyond December 31, 2020, and, commencing January 1,
8 2021, to require all city and county superintendents of
9 education to be appointed by the local board of education
10 pursuant to general law.

11 "Proposed by Act _____."

12 This description shall be followed by the following
13 language:
