1 Enrolled, An Act,

2

3 Relating to the Historic Blakeley Authority; to amend  
4 Section 41-10-171, Code of Alabama 1975; to include as a  
5 member of the authority the member of the Alabama House of  
6 Representatives who is serving the district where the Blakeley  
7 site is situated, in lieu of the member serving District 95.

8 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

9 Section 1. Section 41-10-171 of the Code of Alabama  
10 1975, is amended to read as follows:

11 "§41-10-171

12 (a) The authority shall be composed of 21 members as  
13 follows:

14 (1) Two representatives of education, one to be  
15 appointed by the President of the University of South Alabama  
16 for a two-year term and one to be appointed by the Baldwin  
17 County Board of Education from among school board members, who  
18 are residents of the geographic area that is now Baldwin  
19 County Commission District No. 2 for a two-year term~~+~~.

20 (2) Four elected public officials~~,~~ or their  
21 representatives, who shall be:

22 a. The ~~Chairman~~ Chair of the Baldwin County Commission  
23 or a member of the Baldwin County Commission to be chosen by  
24 the commission to serve during that commissioner's term of  
25 office~~+~~.

26 b. The Sheriff of Baldwin County during his or her term  
27 of office~~+~~.

28 c. The Alabama House of Representatives ~~District 95~~

31 d. The Governor ~~of the State of Alabama~~ or a  
32 representative appointed by him or her to serve during the

34 (3) Three representatives of historic organizations as  
35 follows:

36 a. The ~~president~~ President of the Baldwin County  
37 Historic Society or a person designated by the president for a  
38 two-year term; ~~.~~

39 b. A representative of the Fort Bowyer Chapter,  
40 Daughters of the American Revolution to be chosen by the  
41 chapter for a two-year term; ~~and.~~

42 c. The President of Descendants of Blakeley Residents  
43 or a person designated by the president for a six-year term; ~~.~~

44 (4) Three representatives of public service and civic  
45 organizations as follows:

46 a. A representative of the Eastern Shore Chamber of  
47 Commerce to be selected by the organization for a two-year  
48 term; ~~.~~

49 b. The ~~Chairman~~ Chair of the Board of Directors of the  
50 Tallulah Bankhead Center for the Performing Arts for a  
51 four-year term; ~~and.~~

52 c. The ~~Chairman~~ Chair of the Blakeley Courthouse Museum  
53 Board for a four-year term ~~of four years; and.~~

54 (5) a. Nine at-large members to be appointed by the  
55 Governor from nominations submitted by the Historic Blakeley  
56 Foundation according to the following:

57           ~~a.~~1. Places 1-4 for six-year terms commencing with  
58 their appointment by the Governor~~;~~.

59           ~~b.~~2. Places 5-7 for four-year terms commencing with the  
60 appointment by the Governor~~;~~and.

61           ~~c.~~3. Places 8-9 for two-year terms commencing with  
62 their appointment by the Governor.

63           b. Upon completion of the initial staggered terms all  
64 subsequent appointments of authority members ~~in category 5~~  
65 appointed pursuant to paragraph a. shall be by the same  
66 method, except they shall be for terms of four years.

67           (b) Vacancies on the ~~board~~ authority during a term  
68 shall be filled for the unexpired portion of the term in the  
69 same manner and by the same appointing authority as the member  
70 whose place is being filled."

71           Section 2. This act shall become effective on the first  
72 day of the third month following its passage and approval by  
73 the Governor, or its otherwise becoming law.
