ENROLLED, An Act, 2

> To alter or rearrange the boundary lines of the City of Monroeville, Monroe County, Alabama, so as to include within the corporate limits of the City all territory now within the corporate limits and also certain territory not contiguous thereto, in Monroeville, Monroe County, Alabama.

BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

Section 1. That the boundary lines of the City of Monroeville, Monroe County, Alabama be, and the same are hereby altered or rearranged so as to include all of the territory heretofore encompassed by the corporate limits of the City of Monroeville, and in addition thereto the following described territory, to-wit:
