A BILL
TO BE ENTITLED
AN ACT

To alter, rearrange, and extend the boundary lines and corporate limits of the municipality of Hayden in Blount County.

BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:
Section 1. The boundary lines and corporate limits of the municipality of Hayden in Blount County are altered, rearranged, and extended to include within the corporate limits of the municipality, in addition to the lands now included, all of the following territory:

TRACT 1
A part of the Northeast Quarter of Southwest Quarter and part of the Northwest Quarter of Southeast Quarter of Section 3, Township 13 South, Range 2 West, Blount County, Alabama, more particularly described as follows:

Begin at an iron found (JD Jones) at the Northeast Corner of said Northwest Quarter of Southeast Quarter, thence South 00 Degrees 22 Minutes 22 Seconds East, 1293.67 feet to a pipe found; thence South 89 Degrees 48 Minutes 58 Seconds West 636.48 feet to a capped iron set with red plastic cap stamped CE Hopper PLS20637, on the North Right of Way of Graves Gap Road; thence along Right of Way as follows: Westerly along the arc of a curve concave Southerly, having a radius of 905.94 feet and an arc length of 110.16 feet with a chord bearing of North 84 Degrees 01. Minutes 49 Seconds West and a chord distance of 110.09 feet to a capped iron set; North 88 Degrees 17 Minutes 10 Seconds West, 194.34 feet to a capped iron set on the East Right of Way of Holt Circle; thence along East Right of Way of Holt Circle as follows: North 13 Degrees 53 Minutes 10 Seconds West 49.77 feet to a capped iron set; Northerly along the arc of a curve concave Southwesterly, having a radius of 278.87 feet and an arc length of 120.84 feet with a chord bearing of North 24 Degrees 55 Minutes 05 Seconds West and a chord distance of 119.90 feet to a capped iron set; North 47 Degrees 30 Minutes 53 Seconds West 96.69 feet to a capped iron set; Northerly along the arc of a curve concave Northeasterly, having a radius of 437.55 feet and an arc length of 119.05 feet with a chord bearing of North 41 Degrees 26 Minutes 24 Seconds West and a chord distance of 118.68 feet to a capped iron set; North 32 Degrees 52 Minutes 15 Seconds West 367.99 feet to a capped iron set; Northerly along the arc of a curve concave Northeasterly, having a
radius of 567.22 feet and an arc length of 323.39 feet with a chord bearing of North 18 Degrees 31 Minutes 06 Seconds West and a chord distance of 319.03 feet to a capped iron set; North 05 Degrees 13 Minutes 21 Seconds West 292.51 feet to a capped iron set; Northwesterly along the arc of a curve concave Southwesterly, having a radius of 108.79 feet and an arc length of 87.90 feet with a chord bearing of North 15 Degrees 33 Minutes 39 Seconds West and a chord distance of 85.53 feet to a capped iron set; thence leaving Right of Way run South 89 Degrees 18 Minutes 12 Seconds East 182.62 feet to an iron found (Cherry); thence continue South 89 Degrees 18 Minutes 12 Seconds East, 1312.24 feet to the Point of Beginning. Containing 38.51 acres, more or less.

TRACT 2
A part of the Southwest Quarter of the Southeast Quarter of Section 3, Township 13 South, Range 2 West, Blount County, Alabama, more particularly described as follows: From an iron found (JD Jones) at the Northeast Corner of the Northwest Quarter of Southeast Quarter of said Section 3, thence South 00 Degrees 22 Minutes 22 Seconds East, 1293.67 feet to a pipe found and the Point of Beginning; thence South 00 Degrees 50 Minutes 45 Seconds East, 231.86 feet to a capped iron set with red plastic cap stamped CE Hopper PLS20637, on the North Right of Way of Graves Gap Road; thence along Right of Way as follows: Northwesterly along the arc of a curve concave Northerly, having a radius of 2005.78 feet and an arc length of 286.05 feet with a chord bearing of

North 70 Degrees 22 Minutes 28 Seconds West and a chord distance of 285.81 feet to a capped iron set; North 65 Degrees 56 Minutes 08 Seconds West, 188.26 feet to a capped iron set; Westerly along the arc of a curve concave Southerly, having a radius of 905.94 feet and an arc length of 207.27 feet with a chord bearing of North 73 Degrees 59 Minutes 32 Seconds West and a chord distance of 206.82 feet to a capped iron set; thence leaving Right of Way run North 89 Degrees 48 Minutes 58 Seconds East, 636.48 feet to the Point of Beginning. Containing 1.64 acres, more or less.

Tract 85, of Smoke Rise, Sector One, a map or plat of which is filed for record in Map or Plat Record Vol. 2-A Page 297 in the Office of Judge of Probate, Blount County, Alabama.

Containing 0.64 acres more or less.

Section 2. In accordance with Section 11-42-6(b) of the Code of Alabama 1975, a map showing what territory is proposed to be annexed to the municipality of Hayden is on
file in the office of the Judge of Probate in Blount County, Alabama, and the map is open to the inspection of the public. Section 3. This act shall become effective on the first day of the third month following its passage and approval by the Governor, or its otherwise becoming law.
