ENROLLED, An Act,

To alter, rearrange, and extend the boundary lines and corporate limits of the municipality of Gaylesville in Cherokee County.

BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

Section 1. The boundary lines and corporate limits of the municipality of Gaylesville in Cherokee County are altered, rearranged, and extended to include within the corporate limits of the municipality, in addition to the lands now included, all of the following territory:

Tract One:

The South Half of the Southeast Quarter and the Southeast Quarter of the Southwest Quarter all in Section 10, Township 9 South, Range 10 East;

Tract Two:

That part of the North Half of the Northeast Quarter lying west of Chattooga River; the Northeast Quarter of the Northwest Quarter less and except Lots 5, 7 and 9 of Timberlake Subdivision, Block A as the same appears of record in Plat Book 10 at page 52; The Southeast Quarter of the Northwest Quarter less and except that portion lying East of Shady Lane as shown on the plat of Timberlake Subdivision, Block B, as the same appears of record in Plat Book 10 at page 53; The Southwest Quarter of the Northwest Quarter; Lots 18,

1 19, 20, 21, 22 and 23 of the C. E. Chestnut Jr. Estate, as the
 2 same appears of record in Plat Book 11 at page 8; the
 3 Northeast Quarter of the Northwest Quarter lying north of
 4 Alabama Highway 68, all in Section 15, Township 9 South, Range
 5 10 East;

6 There is excepted from the lands situated in the
 7 Northwest Quarter of said Section, Township and Range the
 8 following:

9 Commence at the Southwest corner of the Northwest
 10 Quarter of Section 15, Township 9 South, Range 10 East and run
 11 North 89 degrees 16 minutes 46 seconds East and along and with
 12 the South boundary line of the Northwest Quarter of said
 13 Section, Township and Range for a distance of 793.12 feet and
 14 to a point; thence run North 39 degrees 04 minutes 09 seconds
 15 West for a distance of 1262.94 feet and to a point; thence run
 16 North 23 degrees 19 minutes 28 seconds West and to a point in
 17 the West boundary line of said Section, Township and Range;
 18 thence run South 0 degrees 45 minutes 04 seconds East for a
 19 distance of 1014.66 feet and to the point of beginning of the
 20 parcel of land hereby excepted.

21 Tract Three:

22 The Southeast Quarter of the Northeast Quarter lying
 23 East of Cherokee County Road #567; the Northeast Quarter of
 24 the Northeast Quarter lying East of Cherokee County Road #567
 25 and South of Alabama Highway #68; Lot 10 of the C. E.

1 Chestnut, Jr. Estate as the same appears of record in Plat
2 Book 11 at a page 8, all in Section 16, Township 9 South Range
3 10 East.

4 Section 2. In accordance with Section 11-42-6(b) of
5 the Code of Alabama 1975, a map showing what territory is
6 proposed to be annexed to the municipality of Gaylesville is
7 on file in the office of the Judge of Probate in Cherokee
8 County, Alabama, and the map is open to the inspection of the
9 public.

10 Section 3. This act shall become effective on the
11 first day of the third month following its passage and
12 approval by the Governor, or its otherwise becoming law.
