| 22 | Section 1. Sections 1, 2, and 3 of Act 2464 of the |
| 23 | 1971 Regular Session (Acts 1971, p. 3929), as amended, are |
| 24 | further amended to read as follows: |
| 25 | "Section 1. In Sumter County, the fee for issuance |
| 26 | of a permit to carry a pistol in a vehicle or concealed on or |
| 27 | about the person as provided in Section 13A-11-75 of the Code |

of Alabama 1975, shall be fifteen dollars (\$15) twenty dollars (\$20) each year, which shall be collected by the sheriff.

"Section 2. Eleven dollars and twenty-five cents (\$16.25) of each fee collected under Section 1 of this act shall be deposited by the Sheriff of Sumter County in any bank located in Sumter County, into a fund known as the "Sheriff's Fund."

Sheriff's Pistol Permit Fund. The Sheriff's Pistol Permit Fund may be drawn upon by the sheriff or his or her appointed agent and shall be exclusively used for law enforcement purposes in the public's interest and in the discharge of the duties of the sheriff's office as the sheriff determines. The Sheriff's Pistol Permit Fund and the use of the fund shall not diminish or take the place of any disbursement or other source of income established for the sheriff or for the operation of the sheriff's office.

"Section 3. Three dollars and seventy-five cents (\$3.75) of the fee collected under Section 1 shall be paid issued by the Sheriff of Sumter County into the general fund of Sumter County to be used for any purpose authorized by the county commission to the Sumter County Commission, to be deposited in the Sumter County Commission General Fund."

Section 2. This act shall become effective on the first day of the third month following its passage and approval by the Governor, or its otherwise becoming law.
