A BILL
TO BE ENTITLED
AN ACT

To alter, rearrange, and extend the boundary lines and corporate limits of the City of Foley in Baldwin County. BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

Section 1. The boundary lines and corporate limits of the City of Foley in Baldwin County are altered, rearranged, and extended to include within the corporate limits of the municipality, in addition to the lands now included, all of the following territory:

TRACT 1: The East half of the East half of the Northwest quarter of Section 26, Township 7 South, Range 3 East, Baldwin County, AL Less and Except PID 05-55-07-26-0-000-004.004. Said tract of land contains 39.95 acres, more or less.

TRACT 2: Outparcel D of Plantation at Magnolia River Phase Four as shown on Slide 2215 C in the records of the
office of the Judge of Probate Court of Baldwin County, AL. Said tract of land contains . 65 acres, more or less.

TRACT 3: From the Northeast corner of Section 26, Township 7 South, Range 3 East, Baldwin County, AL, run South approximately 2,779 feet along the Eastern boundary of said section, thence run West approximately 30 feet to a point on the Western Right-of-Way boundary of Grantham Road and the Point of Beginning; thence Westerly approximately 1,302 feet along said Right-of-Way boundary to a point; thence South approximately 204 feet to a point; thence East approximately 506 feet to a point; thence South approximately 330 feet to a point; thence East approximately 296 feet to a point; thence North approximately 151 feet to a point; thence East approximately 502 feet to a point on the Western Right-of-Way of Grantham Road; thence North along said Right-of-Way boundary approximately 198 feet to a point on said Right-of-Way; thence East approximately 60 feet to a point on the Eastern Right-of-Way boundary of Grantham Road; thence continue East approximately 411 feet to a point; thence North approximately 181 feet to a point on the Southern Right-of-Way boundary of US Highway 98; thence West approximately 412 feet to a point; thence Northwesterly approximately 61 feet to a point on the Western Right-of-Way boundary of Grantham Road and the Point of Beginning. Said tract of land contains 12.59 acres, more or less.

TRACT 4: From the Northwest corner of Section 25, Township 7 South, Range 3 East, Baldwin County, AL, run South approximately 2,677 feet along the Western boundary line of said Section; thence run East approximately 645 feet to a point on the Southern Right-of-Way boundary of US Highway 98 and the Point of Beginning; thence run South approximately 1,271 feet to a point; thence run East approximately 1,976 feet to a point on the Western unused Right-of-Way boundary for Angus West Lane; thence run North along said Western Right-of-Way boundary approximately 858 feet to a point; thence run East approximately 20 feet to a point on the Eastern Right-of-Way boundary of Angus West Lane; thence run South along said Eastern Right-of-Way boundary approximately 70 feet to a point; thence run East approximately 669 feet to a point; thence run South approximately 781 feet to a point; thence run East approximately 331 feet to a point; thence run North approximately 829 feet to a point; thence run East approximately 330 feet to a point; thence run South approximately 180 feet to a point; thence run East approximately 1,284 feet to a point on the Western Right-of-Way boundary of County Road 65; thence run North along said Western Right-of-Way boundary approximately 379 feet to a point; thence run East approximately 71 feet to a point on the Eastern Right-of-Way boundary of County Road 65; thence run South approximately 34 feet to a point; thence run East approximately 649 feet to a point; thence run South approximately 236 feet to a point; thence run East
approximately 369 feet to a point; thence run North approximately 527 feet to a point on the Southern Right-of-Way boundary of US Highway 98; thence run West along said Southern Right-of-Way boundary approximately 5,449 feet to the Point of Beginning. Said tract of land contains 102.27 acres, more or less.

TRACT 5: From the Northwest corner of the Southeast Quarter of Section 30, Township 7 South, Range 4 East, Baldwin County, AL, run North approximately 40 feet to a point on the Northern Right-of-Way boundary of US Highway 98; thence run West approximately along said Right-of-Way boundary 152 feet to the Point of Beginning; thence run North approximately 145 feet to a point; thence run West approximately 152 feet to a point; thence run North approximately 1,152 feet to a point; thence run West approximately 1,000 feet to a point on the Western Right-of-Way boundary of Cash Court; thence run South along said Right-of-Way boundary approximately 823 feet to a point; thence run West approximately 60 feet to a point on the Western Right-of-Way boundary of Cash Court; thence continue West approximately 339 feet to a point; thence run North
approximately 51 feet to a point; thence run West approximately 455 feet to a point; thence run South approximately 221 feet to a point; thence run West approximately 208 feet to a point; thence run South approximately 50 feet to a point; thence run West approximately 250 feet to a point on the Eastern Right-of-Way boundary of County Road 65; thence continue West approximately 70 feet to a point on the Western Right-of-Way boundary of County Road 65; thence continue West approximately 173 feet to a point; thence run North approximately 250 feet to a point; thence run West approximately 1,115 feet to a point; thence run South approximately 497 feet to a point on the Northern Right-of-Way boundary of US Highway 98; thence run East along said Right-of-Way boundary approximately 3,822 feet to the Point of Beginning. Said tract of land contains 57.06 acres, more or less.

Less and Except any used or unused Right-of-Ways and PID 05-55-07-25-0-000-040.000, PID 05-55-07-25-0-000-038.001, and PID 05-55-07-25-0-000-039.000 containing 4.26 acres, more or less.

TRACT 6: From the Southeast corner of the Northwest Quarter of Section 25, Township 7 South, Range 3 East, Baldwin County, AL, run North approximately 55 feet to a point on the Northern Right-of-Way boundary of US Highway 98; thence run West approximately 84 feet to a point on the Western Right-of-Way boundary of Bodenhamer Road and the Point of Beginning; thence run North along said Right-of-Way boundary
approximately 504 feet to a point; thence run West approximately 1,303 feet to a point; thence run North approximately 775 feet to a point; thence run West approximately 1,256 feet to a point on the Eastern boundary of an unused Right-of-Way; thence run South along said Right-of-Way boundary approximately 1,251 feet to a point on the Northern Right-of-Way boundary of US Highway 98; thence run East approximately 380 feet to a point on said Right-of-Way boundary; thence run South approximately 24 feet to a point on the Southern Right-of-Way boundary of US Highway 98; thence run East along said Right-of-Way boundary approximately 2,186 feet to the Point of Beginning. Said tract of land contains 51.75 acres, more or less.

Less and Except any used and unused Right-of-Ways and PID 05-55-07-25-0-000-097.002, PID 05-55-07-25-0-000-097.001, PID 05-55-07-25-0-000-095.000, PID 05-55-07-25-0-000-093.000, PID 05-55-07-25-0-000-092.000, PID 05-55-07-25-0-000-092.001, PID 05-55-07-25-0-000-091.000, PID 05-55-07-25-0-000-090.001, and PID 05-55-07-25-0-000-090.000 containing 25.23 acres, more or less.

Section 2. In accordance with Section 11-42-6(b) of the Code of Alabama 1975, a map showing what territory is proposed to be annexed to the City of Foley is on file in the office of the Judge of Probate in Baldwin County, Alabama, and the map is open to the inspection of the public.

Section 3. This act shall become effective on the first day of the third month following its passage and approval by the Governor, or its otherwise becoming law.
