2 <u>ENROLLED</u>, An Act,

Relating to Winston County; providing for an optional procedure for the renewal of motor vehicle, boat, and business licenses by mail or electronic means by the judge of probate and revenue commissioner; to provide for the mailing fees to be deposited in the county general fund; and to provide for a referendum.

BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

Section 1. The judge of probate may transmit by mail or electronic means an application for renewal of a motor vehicle, boat, or business license to any person to whom a license has been previously issued. The application for renewal may be in a form determined appropriate by the judge of probate and revenue commissioner and shall contain sufficient information to adequately identify and process the renewal. The signature of the licensee on the application and proper remittance shall constitute sufficient authority for the judge of probate to issue the license and return the license to the licensee by mail or electronic means. The county commission may establish a fee of up to three dollars (\$3) for renewals by mail or electronic means not to exceed the administrative cost of the renewals. The fee shall be collected by the judge of probate at the time of issuance and paid to the county general fund.
