To alter, rearrange, and extend the boundary lines and corporate limits of the municipality of Killen in Lauderdale County.

6 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

Section 1. The boundary lines and corporate limits of the municipality of Killen in Lauderdale County are altered, rearranged, and extended to include within the corporate limits of the municipality, in addition to the lands now included, all of the following territory:

12 A tract or parcel of land lying and being in 13 Sections 26 and 27, all in Township 2 South, Range 10 West, 14 Lauderdale County, Alabama, more particularly described as 15 beginning at a point on the North right-of-way line of U. S. 16 Highway 72, said point being 1217.06 feet South and 308.51 17 feet West of the Northeast corner of the Northwest 1/4 of 18 Section 26, Township 2 South, Range 10 West; thence South 22 19 degrees 24 minutes 21 seconds East for 324.27 feet to a point 20 on the South right-of-way line of said U. S. Highway 72; 21 thence along the South right-of-way line of said U. S. Highway 22 72 the following bearings and distances: South 66 degrees 17 23 minutes 25 seconds West for 53.98 feet to a concrete monument, South 46 degrees 14 minutes 52 seconds West for 159.52 feet to 24 25 a concrete monument, South 66 degrees 13 minutes 08 seconds
