ENROLLED, An Act,

Proposing an amendment to the Constitution of Alabama of 1901, to levy an additional one percent sales and use tax on certain items and one-half of one percent on certain other items in Baldwin County to be distributed to any local boards of education in the county in accordance with state law for public school purposes; to provide for the tax, an expiration date for the tax five years from June 1, 2013, and the method for the renewal of the tax; to prescribe penalties and to fix punishment for violation of the amendment; to provide for the collection of the sales and use tax; to provide for exemptions from the sales and use tax; and to provide for the payment of election expenses by the Baldwin County Board of Education.

BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

Section 1. The following amendment to the Constitution of Alabama of 1901, is proposed and shall become valid as a part of the Constitution when all requirements of this act are fulfilled:

PROPOSED AMENDMENT

(a) As used in this amendment, the term "state sales tax" means the tax or taxes imposed by Division 1 of Article 1 of Chapter 23 and by Article 3 of Chapter 23 of Title 40 of the Code of Alabama 1975, as amended (herein called "the

1 Code"), including all other statutes of the State of Alabama
2 (herein called "the state") which expressly set forth any
3 exemptions from the computation of the taxes levied in
4 Division 1 or Article 3 and all other statutes which expressly
5 apply to, or purport to affect, the administration of Division
6 1 or Article 3 and the incidence and collection of the taxes
7 imposed therein; and the term "state use tax" means the tax or
8 taxes imposed by either Article 2 or Article 3 of Chapter 23
9 of Title 40 of the Code, including all other statutes of the
10 state which expressly set forth any exemptions from the
11 computation of the tax levied in Article 2 or Article 3 and
12 all other statutes of the state which expressly apply to, or
13 purport to affect, the administration of Article 2 or Article
14 3 and the incidence and collection of the taxes imposed
15 therein.

16 (b) Subject to the provisions of this amendment,
17 there are hereby levied in Baldwin County (herein called "the
18 county"), in addition to all other taxes now authorized, or
19 that may hereafter be authorized by the Constitution and laws
20 of Alabama, to be levied in the county, sales and use taxes
21 (herein together called "the county sales and use taxes") that
22 parallel, except for the rate or rates of such taxes (as
23 hereinafter specified), the state sales tax and the state use
24 tax. The duration of the levy of the county sales and use
25 taxes hereunder shall be a period of five (5) years,

1 commencing on June 1, 2013, subject to extension or renewal as
2 authorized by the Legislature in accordance with a local
3 legislative act.

4 (c) The rate of the county sales and use taxes shall
5 be one percent on any transaction that is subject to taxation
6 by the state pursuant to the provisions of (i) either
7 subdivision (1), subdivision (2), or subdivision (5) of
8 Section 40-23-2 of the Code, or (ii) subsection (a) of Section
9 40-23-61 of the Code.

10 (d) The rate of the county sales and use taxes shall
11 be one-half of one percent (.5%) on any transaction that is
12 subject to taxation by the state pursuant to the provisions of
13 (i) either subdivision (3) or subdivision (4) of Section
14 40-23-2 of the Code; or (ii) either subsection (b) or
15 subsection (c) of Section 40-23-61 of the Code; (iii) either
16 Section 40-23-37 or Section 40-23-63, Code of Alabama 1975; or
17 (iv) Article 3 of Chapter 23 of Title 40 of the Code, as the
18 case may be.

19 (e) The county sales and use taxes shall, as the
20 Baldwin County Commission (hereafter "the commission") may
21 from time to time determine, be collected either by the
22 commission or by any person, firm, or corporation (whether
23 public or private) with which the commission may contract to
24 collect the county sales and use taxes or any other tax or
25 taxes levied by, or in, the county, all in accordance with,

1 and subject to, applicable provisions of law as are from time
2 to time in effect.

3 (f) All provisions of law from time to time in
4 effect with respect to the payment, assessment, and collection
5 of the state sales tax and the state use tax, and any and all
6 reports, records, and penalties for failure to pay such taxes,
7 the promulgation of rules and regulations with respect to such
8 taxes, and the administration and enforcement of such taxes or
9 such provisions of law (as the case may be), shall, to the
10 extent not inconsistent with this amendment, apply to the
11 county sales and use taxes.

12 (g) The commission shall remit to any local boards
13 of education in the county in accordance with state law all
14 amounts collected by the commission from the sales and use tax
15 levied pursuant to the terms of this amendment, less
16 collection fees charged by the commission in accordance with
17 this amendment, applicable state law and any agreements
18 entered into between the commission and the Baldwin County
19 Board of Education or any local board of education in the
20 county not inconsistent with this amendment or state law.

21 (h) Notwithstanding any provision of law now
22 existing or hereafter enacted by the Legislature, the board of
23 education shall pay, or shall cause to be paid, all costs and
24 expenses incurred (whether by the state, the county or any
25 other political subdivision or public body) in connection with

1 the call, conduct, canvass or contest of any special election
2 hereafter held (whether pursuant to, or in accordance with,
3 the provisions of this amendment or otherwise) for the purpose
4 of levying, or authorizing the levy of, any tax (regardless of
5 the character or nature thereof) all or a majority of the
6 revenues from which may, prior to such special election, be
7 dedicated by constitutional amendment, general law, statute,
8 local legislative act or otherwise (or by ordinance or
9 resolution of the commission) for public school or public
10 educational purposes in the county, or which may be otherwise
11 payable (or paid) to the Baldwin County Board of Education.
12 The provisions of this paragraph shall remain in full force
13 and effect notwithstanding the expiration or termination of
14 any sales or use tax levied, extended or renewed pursuant to
15 other provisions of this amendment.

16 (i) The commission is hereby empowered to collect
17 the county sales and use taxes and to enforce the provisions
18 of this amendment, and it shall have and exercise all rights
19 and remedies that the state has for the collection of the
20 state sales tax and the state use tax (as the case may be).

21 (j) The foregoing provisions of this amendment shall
22 be and are hereby declared to be self-executing; but the
23 Legislature may enact general or local laws that implement,
24 supplement or further any or all of the foregoing provisions
25 of this amendment.

1 Section 2. An election upon the proposed amendment
2 shall be held at the general election on November 6, 2012, in
3 accordance with Amendment 555 to the Constitution of Alabama
4 of 1901, now appearing as Section 284.01 of the Official
5 Recompilation of the Constitution of Alabama of 1901, as
6 amended, and the election laws of this state.

7 Section 3. The appropriate election official shall
8 assign a ballot number for the proposed constitutional
9 amendment on the election ballot and shall set forth the
10 following description of the substance or subject matter of
11 the proposed constitutional amendment:

12 "Relating to Baldwin County, proposing an amendment
13 to the Constitution of Alabama of 1901, to levy an additional
14 one percent sales and use tax on certain items and one-half of
15 one percent on certain other items, to be distributed to any
16 local boards of education in the county in accordance with
17 state law for public school purposes; providing for the tax,
18 an expiration date for the tax five years from June 1, 2013,
19 and prescribing the method for the renewal of the tax;
20 prescribing penalties and fixing punishment for violation of
21 the amendment; providing for the collection of the sales and
22 use tax; providing for exemptions from the sales and use tax;
23 and providing for the payment of special election expenses by
24 the Baldwin County Board of Education.
