1 Enrolled, An Act,

2 Relating to the City of Columbiana in Shelby County; to
3 authorize the City Council of the City of Columbiana to
4 establish and regulate the operation of entertainment
5 districts in the city as designated by the Columbiana City
6 Code; and to authorize the city council to provide penalties
7 for violations.

8 BE IT ENACTED BY THE LEGISLATURE OF ALABAMA:

9 Section 1. This act is adopted pursuant to the
10 authority in subdivision (31) of Section 104 of the
11 Constitution of Alabama of 2022.

12 Section 2. (a) The City Council of the City of
13 Columbiana by ordinance may provide for the establishment of
14 not more than two entertainment districts in the city, as
15 those districts are defined in the Columbiana City Code. The
16 entertainment districts may contain one or more Alcoholic
17 Beverage Control Board licensees in an area that does not
18 exceed one-half mile by one-half mile. The ordinance of the
19 city council shall regulate hours of operation of an
20 entertainment district, may provide for the revocation of the
21 entertainment district designation, and may regulate any other
22 aspect of the operation of entertainment districts.

23 (b) Any retail licensee of the Alabama Alcoholic
24 Beverage Control Board licensed to sell alcoholic beverages
25 for on-premises consumption located in an entertainment
26 district may obtain an entertainment district permit.
27 Notwithstanding any other provision of law, any licensee that
28 receives an entertainment district permit shall comply with

29 all laws and rules governing its license, except that patrons,
30 guests, or members of the licensee may exit the licensed
31 premises with open containers of alcoholic beverages anywhere
32 within the confines of the entertainment district, but may not
33 enter the premises of another licensee with open containers or
34 closed containers of alcoholic beverages acquired elsewhere.
35 In addition, the ordinance shall prohibit a person other than
36 a retail licensee from possessing or bringing in the
37 entertainment district an open or closed container of
38 alcoholic beverages acquired outside of the entertainment
39 district during the hours of operation of the entertainment
40 district.

41 (c) The ordinance of the city council shall be enforced
42 by the City of Columbiana and shall provide penalties for
43 violations of the ordinance as otherwise authorized by law.

44 Section 3. All laws or parts of laws which conflict
45 with this act are repealed.

46 Section 4. This act shall become effective immediately
47 following its passage and approval by the Governor, or its
48 otherwise becoming law.
