8 pharmacy and medical literature including over 40 journal
9 articles and book chapters; and

10 WHEREAS, his professional affiliations include the
11 American Society of Health System Pharmacists, American
12 Pharmaceutical Association, American College of Clinical
13 Pharmacists, American Association of Colleges of Pharmacy,
14 Alabama Society of Health System Pharmacists, Alabama
15 Pharmacist Association, American Association for Higher
16 Education, Alabama Higher Education Partnership, and the A.K.
17 Rice Institute; and

18 WHEREAS, through the years, Dr. Evans has earned
19 widespread admiration and respect for his tireless dedication
20 and exceptional abilities, and he is truly deserving of
21 special commendation and praise; now therefore,
